Unique Application Number	The Unique Application Number is the identification number previously assigned to each Applicant Name to disguise the Applicant Name during the scoring process.
Applicant Name	The Applicant Name reflects the entity's name as submitted on the original application.
Row	Each Row represents an entry in the original lottery. To match the odds in the original lottery, Lottery Position Numbers will be randomly drawn and assigned to each Unique Lottery Entry Number.
