COURSE TITLE: THE ILLINOIS SUPERVISOR-TRAINEE COURSE

This application is exclusively for Education Providers seeking to teach the Illinois Supervisor-Trainee Course. This is considered to be **CONDITIONAL EDUCATION**.

There are three separate versions.

1. There is a six-hour classroom-only version that contains the AQB mandated material that is the same in every jurisdiction as well as the Illinois-specific material.
2. There is the AQB mandated material that is the same in every jurisdiction. It can be taught in a classroom setting or as a distance offering. The maximum number of contact hours is four. However, a three hour version will satisfy the required content. This version excludes any Illinois-specific material.
3. There is a three-hour, classroom-only Illinois jurisdiction version.

Identify which course option you are applying for. Each version requires a separate application and fee. Mark **ONLY** one.
