**ORDER ASSESSING CIVIL MONETARY PENALTY**

The Illinois Department of Financial and Professional Regulation (the "Department"), having conducted an investigation into the business affairs of Ron King, Flora, Illinois, and having found that Ron King has committed violations of Section 0.05(c) of the Pawnbroker Regulation Act [205 ILCS 510/0.01 to 510/15] (the "Act"), hereby issues this ORDER pursuant to Section 0.05(a)(6) of the Act.

**FINDINGS OF FACT**

Ron King operates a business located at 551 East North Avenue, Flora, Illinois.

2. On May 15, 2011, a member of the Flora Police Department visited the business operations of Ron King and interviewed one of its employees.
3. On May 15, 2011, Ron King described the transactions his business conducts to said member of the Flora Police Department.
4. On May 15, 2011, Ron King described transactions whereupon Ron King lends money on the deposit or pledge of physically delivered personal property and is dealing in the purchase of personal property on the condition of selling the property back again at a stipulated price.
5. Section 1 of the Act provides that every individual or business entity that lends money on the deposit or pledge of physically delivered personal property or who deals in the purchase of such property on the condition of selling the property back again at a stipulated price is a pawnbroker.

6. On May 15, 2011, said member of the Flora Police Department informed Ron King his business was conducting transactions that required a pawnbroker's license.
7. Ron King has not applied for a license to conduct a business as a pawnbroker.
8. The Department has not issued Ron King a license to conduct a business as a pawnbroker.
9. Upon information and belief Ron King continues to conduct pawn transactions illegally and in willful disregard of the Act.

### **CONCLUSIONS OF LAW**

Based on the above Findings of Fact, it is CONCLUDED:

Ron King has committed multiple violations Section 0.05(c) of the Act.


### **NOW THEREFORE IT IS HEREBY ORDERED:**

1. Ron King shall be and hereby is assessed a CIVIL MONETARY PENALTY in the amount of \$5,000 pursuant to Section 0.05(a)(6) of the Act;
2. The CIVIL MONETARY PENALTY in the amount of \$5,000 shall be paid no later than sixty (60) days after service of this Order upon Ron King; and
3. The CIVIL MONETARY PENALTY in the amount of \$5,000 shall be satisfied by means of a certified check or money order made payable to the Department of Financial and Professional Regulation.
