ORDER ASSESSING CIVIL MONETARY PENALTY

The Illinois Department of Financial and Professional Regulation, Division of Banking (the "Department"), having conducted an examination of facts related to Super Pawn Jewelry & Loan, LLC, Round Lake Beach, Illinois, and having found that Super Pawn Jewelry & Loan, LLC (PWN.317) has committed a violation of 38 Ill. Admin. Code § 360.160(b), a rule that has been promulgated in accordance with the Pawnbroker Regulation Act [205 ILCS 510/0.01 to 510/15] (the "Act"), hereby issues this ORDER pursuant to the authority provided by Section 0.05(a)(6) of the Act.

FINDINGS OF FACT

The Department FINDS the following:

1. Super Pawn Jewelry & Loan, LLC operates a business located at 2217 N. Route 83, Suites 122 & 123, Round Lake Beach, Illinois.
2. Super Pawn Jewelry & Loan, LLC held a license as a pawnbroker that expired on June 30, 2011.
3. Super Pawn Jewelry & Loan, LLC elected to file an application to renew its pawnbroker's license through the period ending on June 30, 2012.
4. The renewal application filed by Super Pawn Jewelry & Loan, LLC with the Department was postmarked June 7, 2011.
5. 38 Ill. Admin. Code § 360.160(b) provides that all applications for license renewal for the succeeding license period must be mailed and postmarked no later than June 1 of each year.
6. 38 Ill. Admin. Code § 360.160(b) further provides that a Late Filing Fee of \$50 per day shall be assessed for all applications postmarked after June 1 of each year, unless an exception has been granted.
7. Super Pawn Jewelry & Loan, LLC has not been granted an exception by the Department.

CONCLUSIONS OF LAW

Based on the above Findings of Fact, the Department CONCLUDES that:

Super Pawn Jewelry & Loan, LLC has failed to meet the deadline set forth in 38 Ill. Admin. Code § 360.160(b).


NOW THEREFORE IT IS HEREBY ORDERED:

1. Super Pawn Jewelry & Loan, LLC shall be and hereby is assessed a CIVIL MONETARY PENALTY in the amount of \$300 pursuant to Section 0.05(a)(6) of the Act;
2. The CIVIL MONETARY PENALTY in the amount of \$300 shall be paid no later than sixty (60) days after service of this Order upon Super Pawn Jewelry & Loan, LLC. and
3. The CIVIL MONETARY PENALTY in the amount of \$300 shall be made payable to the Department of Financial and Professional Regulation.
