## **ORDER ASSESSING PENALTY FEE**

The COMMISSIONER OF BANKS AND REAL ESTATE (the "Commissioner"), having conducted an examination of the facts related to Marquis Financial & Associates, Inc., 6917 S. South Chicago Avenue, Chicago, Illinois 60637, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987, [205 ILCS 635] (the "Act") and Section 1050.490 of the rules promulgated under the Act [38 Ill. Adm. Code 1050.490] (the "Rules"), hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Commissioner makes the following:

# **FINDINGS**

- 1. That Marquis Financial & Associates, Inc., is an Illinois residential mortgage Licensee holding License No. MB.0006210 located at 6917 S. South Chicago, Illinois, 60637;
- 2. That on April 9, 2004, a supervisory letter was sent by the Commissioner via U.S. first class mail advising Licensee that the Licensee was due to respond to a 2003 compliance examination; and
- 3. That Licensee was not in compliance and had violated the Act for Failure to Respond to an Agency request for information/documentation as requested by a specify Response Due Date; and
- 4. That a written response was due back from Licensee to the Commissioner by December 4, 2004, and such documentation was not received by the Commissioner; and
- 5. That the requested documentation was received by the Commissioner on March 4, 2004; assessing a penalty fee of \$50 per day for 55 days.

# **CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE COMMISSIONER IS OF THE OPINION AND CONCLUDES:

- 1. That notwithstanding notices and other efforts by the Commissioner, Licensee failed to respond to an Agency request for information/documentation in a timely manner; and
- 2. That Licensee is currently complying with the Act and Rules promulgated under the Act.

### **ORDER**

#### NOW THEREFORE IT IS HEREBY ORDERED:

- 1. That Marquis Financial & Associates, Inc., License No. MB.0006210, shall be and hereby is assessed a penalty fee in the amount of \$2,750;
- 2. The penalty fee in the amount of \$2,750 shall be paid no later than thirty (30) days of the effective date of this Order upon Marquis Financial & Associates, Inc.; and
- 3. The penalty fee in the amount of \$2,750 shall be paid by means of a certified check or money order made payable to the:
