## **ORDER ASSESSING FINE**

The COMMISSIONER OF BANKS AND REAL ESTATE (the "Commissioner"), having conducted an examination of the facts related to Omega Mortgage Mall, Inc., 601 S. LaSalle, Suite 730, Chicago, Illinois 60605, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987, (the "Act") and Section 1050.910 of the rules promulgated under the Act [38 Ill. Adm. Code 1050.910] (the "Rules"), hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Commissioner makes the following:

# **FINDINGS**

- 1. That Omega Mortgage Mall, Inc., is an Illinois residential mortgage Licensee holding License No. MB.0004711 and located at 601 S. LaSalle, Suite 730, Chicago, Illinois, 60605;
- 2. That the Commissioner has received copy of an advertisement regarding Omega Mortgage Mall, and that the Commissioner has found that the Licensee violated the following pertaining to the Act; and
- 3. That Licensee was not in compliance and had violated the Advertising Section (1050.910) Section of the Rules; and
- 4. That Licensee is hereby assessed a \$500.00 fine for such violation.

### **CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE COMMISSIONER IS OF THE OPINION AND CONCLUDES:

1. That notwithstanding notices and other efforts by the Commissioner, Licensee failed to comply with Section 1050.910 of the rules promulgated under the Act.

### **ORDER**

### NOW THEREFORE IT IS HEREBY ORDERED:

- 1. That Omega Mortgage Mall, Inc., License No. MB.0004711, shall be and hereby is assessed a fine in the amount of \$500.00;
- 2. The fine in the amount of \$500.00 shall be paid no later than thirty (30) days of the effective date of this Order upon Omega Mortgage Mall, Inc.; and
- 3. The fine in the amount of \$500.00 shall be paid by means of a certified check or money order made payable to the:
