ORDER ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banks and Real Estate, (the "Department"), having conducted an examination of the facts related to Eastbay Mortgage, 105 W. Official Road, Addison, Illinois, 60101, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987, [205 ILCS 635] (the "Act") and the rules promulgated under the Act [38 Ill. Adm. Code 1050] (the "Rules"), hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

- 1. That Eastbay Mortgage is an Illinois residential mortgage Licensee holding License No. MB.0006352 and located at 105 W. Official Road, Illinois, 60101;
- 2. That the Department has received a copy of an advertisement regarding Eastbay Mortgage, and the Department has found that the Licensee advertised rate, but failed to include an annualized percentage rate (APR).

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

- 1. That Licensee failed to comply with Section 1050.930 of the Rules and Section 3-3 of the Act; and
- 2. That Licensee is therefore in violation of Section 4-5(i)(11) and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED:

- 1. That Eastbay Mortgage, License No. MB.0006352, shall be and hereby is assessed a fine in the amount of \$500.00 pursuant to Section 4-5(h)(5) of the Act;
- 2. The fine in the amount of \$500.00 shall be paid no later than thirty (30) days after the effective date of this Order upon Eastbay Mortgage; and
- 3. The fine in the amount of \$500.00 shall be paid by means of a certified check or money order made payable to the:
