**ORDER ASSESSING FINE**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banks and Real Estate, (the "Department"), having conducted an examination of the facts related to M.S.C. Financial, Inc., 811 W. Evergreen, 304B, Chicago, Illinois, 60622, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987, [205 ILCS 635] (the "Act") and the rules promulgated under the Act [38 Ill. Adm. Code 1050.910], hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

**FINDINGS**

1. That M.S.C. Financial, Inc., is an Illinois residential mortgage licensee holding license No. MB.0004724 and located at 811 W. Evergreen, 304B, Chicago, Illinois, 60622;
2. That the Department has received a copy of an advertisement regarding M.S.C. Financial, Inc., and the Department has found that the Licensee did not include an office address in said advertisement; and
3. That Licensee was not in compliance and had violated the Advertising Section 1050.940 of the Rules and Section 3-3 of the Act.

**CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

1. That Licensee failed to comply with Section 1050.940 of the Rules and Section 3-3 of the Act; and
2. That Licensee is therefore in violation of Section 4-5(i)(11) and (17) of the Act.

**ORDER**

NOW THEREFORE IT IS HEREBY ORDERED:

1. That M.S.C. Financial, Inc., license No. MB.0004724, shall be and hereby is assessed a fine in the amount of \$500.00 pursuant to Section 4-5(h)(5) of the Act;
2. The fine in the amount of \$500.00 shall be due within thirty (30) days after the effective date of this Order upon M.S.C. Financial, Inc.; and
3. The fine in the amount of \$500.00 shall be paid by means of a certified check or money order made payable to the:
