ORDER REVOKING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banks and Real Estate (the "Department"), having conducted an examination of the facts related to Illiana Mortgage Company, 18249 W. Street, Lansing, Illinois, 60438, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635], and Section 1050.480 of the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050.480], hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

- 1. That Illiana Mortgage Company, is an Illinois residential mortgage Licensee holding license No. MB.0005843 and located at 18249 W. Street, Lansing, Illinois, 60438; and
- 2. That on September 9, 2004, the Department conducted a supervisory meeting with Licensee.
- 3. That Licensee was advised by the Department to file a change of ownership and control form with the Department to reflect the new owner.
- 4. That the Department has not had any contact from Licensee, as of October 18, 2004.
- 5. That on January 25, 2005, the Department mailed to Licensee a Potential Disciplinary Action letter via certified and U.S. first class mail service.
- 6. That on January 31, 2005, the Department received return mailed stamped "moved left no address, return to sender, unable to forward."
- 7. That on February 4, 2005, the Department received return mailed stamped "moved left no address, return to sender.

ORDER

IT IS THEREFORE ORDERED that the license of ILLIANA MORTGAGE COMPANY is revoked by Order of the Department, effective ten days from the date of this Order, unless you request a hearing pursuant to the RMLA and Subpart N of the Rules, including remitting the hearing fee required by Section 1050.270 of the Rules.
