ORDER ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banks and Real Estate, (the "Department"), having conducted an examination of the facts related Franklin Home Funding Corp., Inc. 15345 S. Cicero Avenue, Oak Forest, Illinois, 60452, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987, [205 ILCS 635] (the "Act") and the rules promulgated under the Act [38 Ill. Adm. Code 1050] (the "Rules"), hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

- 1. That Franklin Home Funding Corp, Inc. is an Illinois residential mortgage Licensee holding License No. MB.0002028 and located at 15345 S. Cicero Avenue, Oak Forest, Illinois, 60452; and
- 2. That Licensee failed to provide proof to the Department of completion of continuing education requirements for one (3) loan officers for 2003 during its license renewal.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

1. That Licensee violated Section 1050.360 (Continuing Educational Requirements for Certain Employees) of the Rules for calendar year 2003.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED:

- 1. That Franklin Home Funding Corp, Inc., License No. MB.0002028, shall be and hereby is assessed a fine in the amount of \$1,500.00;
- 2. The fine in the amount of \$1,500.00 shall be due within thirty (30) days after the effective date of this Order upon Franklin Home Funding Corp, Inc.; and
- 3. The fine in the amount of \$1,500.00 shall be paid by means of a certified check or money order made payable to the:
