## **ORDER RESCINDING REVOCATION**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking, (the "Department"), having conducted an examination of the facts related to Gettysburg Mortgage Company, LLC, 724 West Algonquin Road, Arlington Heights, Illinois, 60005, (the "Licensee"), and having found that the Licensee did not commit a violation of the Residential Mortgage License Act of 1987 [205 ILCS 635] (the "Act"), and of the rules promulgated under the Act [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

#### **FINDINGS**

- 1. That Gettysburg Mortgage Company, LLC, is an Illinois residential mortgage licensee holding license No. MB.0006668 and located at 724 West Algonquin Road, Arlington Heights, Illinois, 60005;
- 2. That on October 25, 2006 the Department attempted to conduct a special examination of Licensee at the address then properly on file with the Department at 529 West Golf Road, Arlington Heights, Illinois, 60005;
- 3. That Licensee had improperly attempted to file a change of address in a license renewal application and the Department did not receive a properly filed change of address application until October 26, 2006 and after the attempted special examination;
- 4. That the Department sent notices of pending discipline to the Licensee and Licensee's registered agent, but the Department did not receive communication from Licensee to prevent issuance of Order No. 2007-MBR-02; and
- 5. That the Licensee has provided a current office location on file with the Department to enable the Department to examine and regulate Licensee under the Act and Rules.

# **CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

Licensee has not violated Sections 2-4 (a) and 3-4 of the Act and Rules Sections 1050.340 and 1050.480 and is therefore in not in violation of Section 4-5(i)(11) and (17) of the Act.

### **ORDER**

NOW THEREFORE IT IS HEREBY ORDERED:

That Department Order No. 2007-MBR-02 shall be and hereby is rescinded.
