ORDER REVOKING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking, (the "Department"), having conducted an examination of the facts related to Gettysburg Mortgage Company, LLC, 724 West Algonquin Road, Arlington Heights, Illinois, 60005, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987 [205 ILCS 635] (the "Act"), and of the rules promulgated under the Act [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

- 1. That Gettysburg Mortgage Company, LLC, is an Illinois residential mortgage licensee holding license No. MB.0006668 and located according to the Department records at 724 West Algonquin Road, Arlington Heights, Illinois, 60005;
- 2. That commencing October 25, 2006 the Department conducted a special examination of Licensee and the examiner found that the Licensee is not at office location provided to the Department for conducting licensed activities;
- 3. That the Department obtained the name and address of the registered agent for Gettysburg Mortgage Company, LLC from the Illinois Secretary of State's Corporate LLC Database as follows: Robert F. Moore, Registered Agent, 18 Mundhank Road, South Barrington, IL 60010;
- 4. That on November 22, 2006, the Department sent to the registered agent for Licensee a Potential Disciplinary Action letter via U.S. first-class mail service, and U.S. certified mail advising Licensee via its registered agent that the Licensee must provide correct office location and submit to examination or the Department will issue an order revoking the license;

5. That the Department received said Potential Disciplinary Action letter return mail on November 28, 2006, stamped "return to sender"; and

6. That the Licensee has failed to provide and maintain an office and current contact and address information with the Department in violation of the Act and Rules.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

Notwithstanding notices and other efforts by the Department, Licensee has failed to comply with Sections 2-4 (a) and 3-4 of the Act and Rules Sections 1050.340 and 1050.480 and is therefore in violation of Section 4-5(i)(11) and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED that the license of GETTYSBURG MORTGAGE COMPANY, LLC., License No. MB.0006668 is revoked by Order of the Department pursuant to Section 4-5(h)(1) of the Act for failure to comply with the provisions cited herein of the Act and Rules, effective ten days after receipt of this Order, unless you request a hearing pursuant to the RMLA and Subpart N of the Rules, including remitting the hearing fee required by Section 1050.270 of the Rules.
