ORDER ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), having conducted a review of activities conducted by **Discount Mortgage Lenders, Inc.**, (the "Licensee") and having documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

1. That Discount Mortgage Lenders, Inc is an Illinois residential mortgage licensee holding license number MB.0006871 (the "License"), and located at 2625 Butterfield Road, Suite 104S, Oak Brook, IL 60523;
2. That Licensee has failed to perform one or more of the requirements of the Act and Rules described below:
 - a. Failure of Licensee to maintain Surety Bond (205 ILCS 635/3-1 and 38 Ill. Adm. Code 1050.490);
3. That the Department made efforts as described below to advise Licensee of these unfulfilled requirements so that Licensee can comply with the Act and Rules:
 - a. That on February 28, 2007, the Department received a Notice of Cancellation letter from Licensee's Insurance Company indicating that coverage shall expire thirty days after receipt of said notice;
 - b. That on March 19, 2007, the Department sent to Licensee via U.S. first-class mail service and certified mail, a letter advising Licensee that the surety bond on file with the Department had been cancelled and that a current bond must be submitted to Department within 10 days;

- c. That a Potential Disciplinary Letter was sent to Licensee on July 31, 2007 via U.S. first-class mail service and certified mail. A signed receipt card evidencing receipt of such delivery was received by the Department on August 6, 2007; and
- d. That Licensee has not submitted to the Department a current surety bond by the due date.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

1. That notwithstanding notices and other efforts by the Department, Licensee failed to respond and submit a current surety bond to the Department in a timely manner; and
2. That Licensee is not currently complying with the Act and Rules promulgated under the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED:

1. That Discount Mortgage Lenders, Inc, License No. MB.0006871 shall be and hereby is assessed a fine in the amount of \$2,500;
2. The fine in the amount of \$2,500 shall be paid no later than thirty (30) days after service of this Order upon Discount Mortgage Lenders, Inc; and
3. The fine in the amount of \$2,500 shall be paid by means of a certified check or money order made payable to the:
