ORDER SUSPENDING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), having conducted a review of activities related to licensed activities conducted by **Pathway Mortgage**, **LLC**, (the "Licensee") and having documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

- 1. That Pathway Mortgage, LLC is an Illinois residential mortgage licensee holding license number MB.6760064 (the "License"), and located at 26100 American Drive, Suite 401, Southfield, Michigan 48034-6183;
- 2. That Licensee has failed to perform one or more of the requirements of the Act and Rules described below:
 - a. Failure of Licensee to maintain Surety Bond (205 ILCS 635/3-1 and 38 III. Adm. Code 1050.490);
- 3. That the Department made efforts as described below to advise Licensee of these unfulfilled requirements so that Licensee can comply with the Act and Rules:
 - a. That on July 24, 2007, the Department sent to Licensee a letter via U.S. mail service advising Licensee that the surety bond on file with the Department had expired on July 1, 2007 and that a current bond must be submitted to the Department within 10 days; and

b. That a Potential Disciplinary Letter was sent to Licensee on October 12, 2007 via

U.S. first-class mail service and certified mail;

c. That Licensee has not submitted to the Department a current surety bond by the due

date.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND

CONCLUDES:

1. That notwithstanding notices and other efforts by the Department, Licensee failed to respond

and submit a current surety bond to the Department in a timely manner; and

2. That Licensee is not currently complying with the Act and Rules promulgated under the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED that the license of Pathway Mortgage, LLC, License

No. MB.6760064 is suspended by Order of the Department pursuant to Section 4-5(h) (2) of the Act for

failure to comply with the provisions cited herein of the Act and rules, effective ten days after receipt of

this Order, unless you request a hearing pursuant to the Act and Subpart N of the Rules, including

remitting the hearing fee required by Section 1050.210 of the Rules.
