ORDER RESCINDING REVOCATION

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking ("Department"), having reopened its review of activities by Spectrum Financial Services, Inc. ("Spectrum Financial") in relation to its Illinois residential mortgage license number MB.0006172 ("License"), hereby issues this ORDER pursuant to the Residential Mortgage License Act of 1987 ("Act") [205 ILCS 635].

STATUTORY PROVISIONS

1. Section 2-6(e) of the Act provides that a licensee ceasing an activity or activities regulated by this Act and desiring to no longer be licensed shall so inform the Department in writing and, at the same time, convey the license and all other symbols or indicia of licensure. The licensee shall include a plan for the withdrawal from regulated business, including a timetable for the disposition of business, and comply with the surrender guidelines or requirements of the Department. Upon receipt of such written notice, the Department shall post the cancellation or issue a certified statement canceling the license.

FACTUAL FINDINGS

- 2. On August 15, 2007, the Department issued the Order against Spectrum Financial revoking its License for failure to properly surrender; and
- 3. The Department reopened its records related to the License surrender application by Spectrum Financial and found that Spectrum Financial did provide the information and/or documentation requested by the Department at the time of the surrender application process.

LEGAL CONCLUSIONS

4. The Department has determined through its review that Spectrum Financial did submit a complete License surrender application to the Department and did not violate the Act as cited in Order No. 2007-MBR-65.

NOW IT IS HEREBY ORDERED THAT:

1. The Department **RESCINDS** Order No. 2007-MBR-65 and surrenders Spectrum Financial's License.

Absent a request for a hearing, this Order shall constitute a final administrative Order subject to the Administrative Review Law [735 ILCS 5/3-101 et seq.].
