ORDER REVOKING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), having conducted a review of licensable activities conducted by New Generation Financial Services, LLC, 1926 W. Irving Park Road, Chicago, Illinois, 60613, (the "Licensee") and having documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5(h)(1) of the Act. The Department makes the following:

FINDINGS

- 1. That New Generation Financial Services, LLC, is an Illinois residential mortgage licensee holding license number MB.6759844 (the "License"), and located at 1926 W. Irving Park Road, Chicago, Illinois, 60613;
- 2. That between September 25, 2008 and December 22, 2008, a Department examiner made multiple attempts to schedule Licensee for its regular examination as required pursuant to Section 4-2 of the Act and Section 1050.425 of the Rules:
- 3. That Licensee failed to respond to the Department's exam-scheduling attempts, was removed from the Department's examinations schedule, and referred for enforcement;
- 4. That a Potential Disciplinary Letter was sent to Licensee on March 30, 2009, via U.S. first-class and certified mail service:
- 5. That said letters sent via U.S. first-class and certified mail service were returned on April 6, 2009 and April 10, 2009, to the Department, by the U.S. Postal Service as "Return to Sender, Not Deliverable As Addressed Unable to Forward Not Known; and
- 6. That Licensee has failed to submit to examination and respond to the Department the requests for information or documentation by the due dates as requested by the Department.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND

CONCLUDES:

That notwithstanding notices and other efforts by the Department, Licensee is in violation of Sections 2-4(u), 4-1(r) 4-2, and 4-4 of the Act, and Section 1050.425 of the Rules, and is in

further violation of Sections 4-5(i) (11) and (15) and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED that the license of NEW GENERATION

FINANCIAL SERVICES, LLC License No. MB.6759844, is revoked by Order of the Department

pursuant to Section 4-5(h) (1) of the Act for failure to comply with the provisions cited herein of the Act

and rules, effective ten days after receipt of this Order, unless you request a hearing pursuant to the Act

and Subpart N of the Rules, including remitting the hearing fee required by Section 1050.210 of the

Rules.
