ORDER REVOKING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), having reviewed activities conducted by PTF Financial Corp. (the "Licensee") and having documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5 (h)(1) of the Act. The Department makes the following:

FINDINGS

- 1. That PTF Financial Corp. is an Illinois residential mortgage licensee holding inactive, lapsed license number MB.6760220 (the "License") and located according to Department records at 10333 E. Dry Creek Road, Suite 200, Englewood, Colorado 80112.
- 2. That the Department has created an enforcement issue for Licensee's failure to comply with the Act and Rules for the following items: 1) failure to submit its 2007 financial statements, 2) failure to document and maintain net worth, 3) failure to renew surety bond on 12/8/2008 and fidelity bond on 9/1/2008, and 4) failure to renew License in timely manner and provide change of address as Department correspondence was returned by the U.S. Postal Service on 2/24/2009 as "Return to Sender Unclaimed Unable to Forward."

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

That notwithstanding notices and other efforts by the Department, Licensee is in violation of Sections 2-4, 2-6, 3-1, 3-2, and 3-5 of the Act, and Sections 1050.480 and 1050.490 of the Rules, and is in further violation of Sections 4-5(i) (11) and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED that the license of PTF FINANCIAL CORP., License No. MB.6760220 is revoked by Order of the Department for failure to comply with the provisions cited herein of the Act and Rules, effective ten days after receipt of this Order, unless you request a hearing pursuant to the Act and Subpart N of the Rules, including remitting the hearing fee required by Section 1050.210 of the Rules.
