**ORDER REVOKING LICENSE**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the “Department”), having reviewed the activities conducted by MetroMidwest Mortgage (the “Licensee”) and having documented violations of the Residential Mortgage License Act of 1987 (the “Act”) [205 ILCS 635] and the rules promulgated under the Act (the “Rules”) [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5(h)(1) of the Act. The Department makes the following:

**FINDINGS**

1. That MetroMidwest Mortgage is an Illinois residential mortgage licensee holding inactive license number MB.6759193 (the “License”) and located, according to Department records, at 15301 Ventura Boulevard, Suite D300, Sherman Oaks, California 91403;
2. That Licensee failed to submit a complete application to renew the License during the 2008-2009 renewal cycle as required by Section 2-6 of the Act and was notified of the deficiency by the Department’s Licensing Section via letter sent U.S. first class mail;
3. That the Licensee took no steps to timely apply for surrender of the License and report change of business activities to the Department; and
4. That on June 29, 2009, the Licensing Section created an enforcement issue for failure to renew the License in a timely manner, and a review of the facts presented establishes that Licensee is not in compliance with the Act and Rules.

**CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

That notwithstanding notices and other efforts by the Department, Licensee is in violation of Sections 2-4(s) & (t) and 2-6 of the Act, and Sections 1050.475 of the Rules, and is in further violation of Sections 4-5(i) (11) and (17) of the Act.

**ORDER**

NOW THEREFORE IT IS HEREBY ORDERED that the license of METROMIDWEST MORTGAGE, License No. MB.6759193 is revoked by Order of the Department pursuant to Section 4-5(h) (1) of the Act for failure to comply with the provisions cited herein of the Act and Rules, effective ten days after receipt of this Order, unless you request a hearing pursuant to the Act and Subpart N of the Rules, including remitting the hearing fee required by Section 1050.210 of the Rules.
