ORDER REVOKING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), having examined True Mark Mortgage Corporation, (the "Licensee") and documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5(h)(1) of the Act. The Department makes the following:

FINDINGS

1. That True Mark Mortgage Corporation is an Illinois residential mortgage licensee holding inactive, lapsed license number MB.0007024 (the "License") and located according to Department records at 780 McArdle Drive, Suite D, Crystal Lake, IL 60014;
2. That the Licensee applied for surrender of the License, and in response to Licensee's application to surrender its Illinois residential mortgage license, the Department contacted Licensee by U.S. first-class mail on November 3, 2008 for purposes of identifying deficient items for the Licensee in its surrender application including open supervision issues from Licensee's examination for period 04/01/2005 to 09/30/2007 and outstanding examination fee of \$1,404.20;
3. That the Licensee was provided with a due date in this deficiency letter in which Licensee was required to supply all missing information/documentation or advised that the Licensee's file would be submitted to the Legal Section to begin the revocation process; and
4. That Licensee has failed to make corrections to deficiencies and practices, failed to pay its outstanding exam fee, and failed to comply with the Act and Rules.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

That notwithstanding notices and other efforts by the Department, Licensee is in violation of Sections 2-4, 2-6 of the Act, and Section 1050.210 of the Rules, and is in further violation of Sections 4-5(i) (11, (13), and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED that the license of **TRUE MARK MORTGAGE CORPORATION**, License No. MB.0007024 is revoked by Order of the Department pursuant to Section 4-5(h)(1) of the Act for failure to comply with the provisions cited herein of the Act and Rules, effective ten days after receipt of this Order, unless you request a hearing pursuant to the Act and Subpart N of the Rules, including remitting the hearing fee required by Section 1050.210 of the Rules.
