ORDER REVOKING LICENSE & ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the “Department”), has examined and having supervised the activities of Casement Mortgage Brokers, Inc., (the “Licensee”) and documented violations of the Residential Mortgage License Act of 1987 (the “Act”) [205 ILCS 635] and the rules promulgated under the Act (the “Rules”) [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5(h)(1) & (5) of the Act. The Department makes the following:

FINDINGS

1. That Casement Mortgage Brokers, Inc., is an Illinois residential mortgage licensee holding license number MB.0006413 (the “License”) and located according to Department’s records at 1595 Weld Road, Suite 4, Elgin, Illinois, 60123;
2. That the Department’s Mortgage Examination Section (“Examination”) of the Department attempted to schedule and conduct an examination by placing telephone calls to Licensee on May 24, 2010, June 18, 2010, and August 12, 2010;
3. That the Examiner calls were not answered by Licensee and that on August 20, 2010, the Examination closed and cancelled its exam file, and on or around August 24, 2010, that Examination Section referred this examination file to Legal with the recommendation that a license revocation action be taken against Licensee;
4. That on October 7, 2010 the Department’s Legal Section mailed to Licensee by U.S. first-class and certified mail service a Potential Discipline Letter citing the aforementioned violations;
5. That on October 13, 2010, a signed receipt card evidencing receipt of such delivery was received by the Department from the U.S. Postal Service; and

6. That the Department has not received a written response from Licensee and based upon the findings and evidence in this matter Licensee has violated the Act and Rules as cited herein.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

That notwithstanding notices and other efforts by the Department, Licensee is in violation of Act Sections 2-4(u) and 4-2, and Rules Section 1050.425, and is in further violation of Sections 4-5(i) (11), (15) and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED:

1. The Department revokes **CASEMENT MORTGAGE BROKERS, INC.**, License No. MB.0006413.
2. The Department assesses a fine against **CASEMENT MORTGAGE BROKERS, INC.**, License No. MB.0006413, in the amount of ten thousand dollars (\$10,000) for violating the Act and Rules as cited herein payable by certified check or money order within thirty (30) days of the effective date of this order to the:

You are hereby notified that this Order is an administrative decision. Pursuant to 205 ILCS 635/4-12 and 38 Ill. Adm. Code, 1050.1510 *et seq.* any party may file a request for a hearing on an administrative decision. The request for a hearing and \$500 hearing fee shall be filed within 10 days after the receipt of an administrative decision. The request for hearing must include an explicit admission, denial or appropriate response to each allegation or issues contained in the administrative decision pursuant to 38 Ill. Adm. Code 1050.1570. A hearing shall be held on the administrative decision by the Department of Financial and Professional Regulation, Division of Banking. Absent a request for a hearing, this Order shall constitute a final administrative Order subject to the Administrative Review Law [735 ILCS 5/3-101 *et seq.*].
