ORDER REVOKING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), conducted an investigation in regards to a fraudulent real estate transaction involving Caliber Financial, LLC, (the "Licensee") and documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5(h)(1) of the Act. The Department makes the following:

FINDINGS

- 1. That Caliber Financial, LLC, is an Illinois residential mortgage licensee holding license number MB.6760591 (the "License") and located according to Department records at 5511 N. Lincoln Avenue, Chicago, Illinois, 60625;
- 2. That on January 12, 2010, the Department's Investigation Section has filed a Report of Investigation (the "ROI") and created an enforcement issue for failure to notify the Department that Licensee ceased mortgage brokering activities of their corporate office and improper surrender of its License;
- 3. That a Potential Disciplinary Letter was sent to Licensee on March 1, 2010, via U.S. first-class and certified mail service;
- 4. That said letters sent via U.S. first-class and certified mail service were returned on March 11, 2010 and March 15, 2010, to the Department, by the U.S. Postal Service; and
- 5. That Licensee has failed to properly renew the License or provide to the Department the requested information or documentation for its License surrender application by the due dates as requested by the Department.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS. THE DEPARTMENT IS OF THE OPINION AND **CONCLUDES:**

That notwithstanding notices and other efforts by the Department, Licensee is in violation of Sections 2-4, 2-6 of the Act, and Section 1050.475 of the Rules, and is in further violation of Sections 4-5(i) (11) and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED that the license CALIBER FINANCIAL, LLC,

License No. MB.6760591 is revoked by Order of the Department pursuant to Section 4-5(h)(1) of the

Act for failure to comply with the provisions cited herein of the Act and Rules.

You are hereby notified that this Order is an administrative decision. Pursuant to 205 ILCS 635/4-12 and 38 Ill. Adm.
