# **ORDER RESCINDING FINE**

The ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), having reviewed the circumstances surrounding issuance of Order No. 2010-MBR-83 ("Order") assessing a fine to Home Servicing, LLC (the "Licensee") under Illinois residential mortgage license number MB.6760347 (the "Licensee"), now makes the following findings:

#### **FINDINGS**

- 1. That the Department mailed to Licensee the Loan Servicer/Loan Modification Semi-Annual Survey referenced in the Order ("Survey") at a former License and mailing address, rather than mailing the Survey to the address on the current License;
- 2. That the Licensee has previously completed a proper change of address with the Department as contained in the Licensee's corporate licensing file and said record to be reflected in the Department's licensing database; and
- 3. That the Licensee had filed and completed its Loan Servicer/Loan Modification Semi-Annual Survey referenced in the Order ("Survey") per the Department requirements in a timely manner per the administrative hearing findings.

# **CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

Licensee did not violate the statutory provisions cited in the Order.
