### ORDER RESCINDING REFUSAL TO RENEW LICENSE AND FINE

4. MTGLQ has completed its License renewal application for calendar year 2012 and is in compliance with the Act.

- 1. The Department **RESCINDS** Order No. 2012-MBR-11.
- 2. The Department shall process MTGLQ's License renewal application for calendar year 2012.

You are hereby notified that this Order is an administrative decision. Pursuant to 205 ILCS 635/4-12 and 38 Ill. Adm. Code, 1050.1510 et seq. any party may file a request for a hearing on an administrative decision. The request for a hearing and \$500 hearing fee by certified check or money order shall be filed with the Department at 320 West Washington Street, 5<sup>th</sup> Floor, Springfield, IL 62786 within 10 days after the receipt of an administrative decision. The request for hearing must include an explicit admission, denial, or appropriate response to each allegation or issue contained in the administrative decision pursuant to 38 Ill. Adm. Code 1050.1570. A hearing shall be held on the administrative decision, by the Department of Financial and Professional Regulation, Division of Banking.
