## **ORDER RESCINDING REVOCATION & FINE**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking ("Department"), having reopened, through a surety bond claim, its review of **PARAMOUNT HOME LOAN CORPORATION** ("PARAMOUNT"), 850 E. Higgins Rd., Suite 125L, Schaumburg, Illinois 60173, and making findings under the Residential Mortgage License Act of 1987 ("Act") [205 ILCS 635] and the rules promulgated thereunder [38 IL Adm. Code 1050] ("Rules"), hereby issues this **ORDER RESCINDING REVOCATION & FINE**.

# STATUTORY PROVISIONS

1. Section 2-6(e) of the Act provides that a licensee ceasing an activity or activities regulated by this Act and desiring to no longer be licensed shall so inform the Department in writing and, at the same time, convey the license and all other symbols or indicia of licensure. The licensee shall include a plan for the withdrawal from regulated business, including a timetable for the disposition of business, and comply with the surrender guidelines or requirements of the Department.

## **FACTUAL FINDINGS**

- 2. The Department issued Order No. 2013-MBR-29 ("Order") on July 26, 2013 upon finding that PARAMOUNT failed to properly complete the surrender of its Illinois Residential Mortgage License No. MB.6760625 ("License").
- 3. The Department has found sufficient documentation of PARAMOUNT'S loan application log and confirmed that no moneys are outstanding to the Department.

### LEGAL CONCLUSIONS

4. The Department finds PARAMOUNT'S's License surrender application to be complete.
