## **ORDER RESCINDING REVOCATION & FINE**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking ("Department"), having reopened, through a surety bond claim, its review of **SECURITY MORTGAGE**, **INC.** ("SECURITY MORTGAGE"), 15 Spinning Wheel Rd., Suite 410, Hinsdale, Illinois 60521, and making findings under the Residential Mortgage License Act of 1987 ("Act") [205 ILCS 635] and the rules promulgated thereunder [38 IL Adm. Code 1050] ("Rules"), hereby issues this **ORDER RESCINDING REVOCATION & FINE**.

## STATUTORY PROVISIONS

1. Section 2-6(e) of the Act provides that a licensee ceasing an activity or activities regulated by this Act and desiring to no longer be licensed shall so inform the Department in writing and, at the same time, convey the license and all other symbols or indicia of licensure. The licensee shall include a plan for the withdrawal from regulated business, including a timetable for the disposition of business, and comply with the surrender guidelines or requirements of the Department.

## **FACTUAL FINDINGS**

- 2. The Department issued Order No. 2013-MBR-77 ("Order") on December 13, 2013 upon finding that SECURITY MORTGAGE failed to properly complete the surrender of its Illinois Residential Mortgage License No. MB.0003111 ("License").
- 3. SECURITY MORTGAGE applied for its License surrender at or near the time that Order 2011–MBR-11 ("Prior Order") was issued and SECURITY MORTGAGE's application was complete except for the Prior Order. Upon further review, SECURITY MORTGAGE may not received notice of the Prior Order at the time of its License surrender application; however, the Department has since received payment for the Prior Order.

### LEGAL CONCLUSION

4. The Department finds SECURITY MORTGAGE'S License surrender application to be complete.

You are hereby notified that this Order is an administrative decision. Pursuant to 205 ILCS 635/4-12 and 38 Ill. Adm. The request for hearing must include an explicit admission, denial, or appropriate response to each allegation or issue contained in the administrative decision pursuant to 38 Ill. Adm. Code 1050.1570. A hearing shall be held on the administrative decision, by the Department of Financial and Professional Regulation, Division of Banking. Absent a request for a hearing, this Order shall constitute a final administrative Order subject to the Administrative Review Law [735 ILCS 5/3-101].
