REFUSE TO RENEW ORDER
LOAN ORIGINATOR REGISTRATION

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking, (the “Department”), having reviewed the renewal application of registered Loan Originator Daniel Ford, (the “Registrant”), 285 Hill Ave, Glen Ellyn, Illinois 60137 and having documented violations of the Residential Mortgage License Act of 1987 (the “Act”) [205 ILCS 635] and the rules promulgated under the Act (the “Rules”) [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 7-1 of the Act and Section 1050.2170 of the Rules. The Department makes the following:

FINDINGS

1. That Registrant is an Illinois Loan Originator registrant holding certificate of registration No. 031.0006626 and having the address of 285 Hill Ave, Glen Ellyn, Illinois 60137;
2. That the Department became aware through the renewal process that Registrant is unfit for registration due to tax violations and inability to demonstrate financial responsibility in violation of the Act and Rules.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

Registrant was in violation of Rules Section 1050.2112 (b) and 1050.2185.

ORDER

IT IS HEREBY ORDERED that the Loan Originator Certificate of Registration 031.0006626 is refused to renew by Order of the Department pursuant to Section 1050.2170(a) of the Rules and Section 7-1 of the Act.
