ORDER ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking, (the "Department"), having conducted an investigation of the facts related to registered Loan Originator MICHAEL TADROS, (the "Registrant"), 6130 51st Street South, St. Petersburg, FL 33715, and having found that the Registrant has committed violations cited herein of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635], and of the rules promulgated under the Act (the "Rules") [38 III. Adm. Code 1050], hereby issues this Order Assessing Fine pursuant to the authority provided under Section 7-1 of the Act and Section 1050.2170 of the Rules. The Department makes the following:

FINDINGS

- That Registrant holds an expired Illinois Loan Originator registration number 031.0026151 and has the address of 6130 51st Street South, St. Petersburg, FL 33715;
- 2. That Registrant was working under the Illinois residential mortgage license of Gateway Capital Mortgage, Inc. (License No. MB. 676411; hereinafter "Gateway") for all purposes of this Order;
- 3. That Registrant did not receive an Illinois Loan Originator registration until December 23, 2008;
- 4. That the Department was notified by Complainant that Registrant was originating loans using Nevene Tadros' ("Tadros"), the owner of Gateway, name and registration number (031.023602) in order to close loans in Illinois; and
- 5. That Registrant knowingly used a name and registration number belonging to another loan originator because Registrant was unqualified to originate loans because he was not licensed. Registrant's actions were a misrepresentation to

the consumers and lenders Registrant worked with and also constitutes dishonest dealings in violation of the Act and the Rules.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

Registrant's activities warrant a fine pursuant to Rule Sections 1050.2165 (b) (c) and (e).

ORDER

NOW THEREFORE IT IS HEREBY ORDERED:

- 1. That MICHAEL TADROS shall be and hereby is assessed a fine of \$1,000 for violating the Act and Rules cited herein pursuant to Rule section 1050.2170(a)(2);
- 2. The total fine in the amount of \$1,000 shall be due thirty (30) days after the effective date of this Order; and
- 3. The fee in the amount of \$1,000 shall be paid by means of a certified check or money order made payable to the:
