## ORDER ASSESSING FINE

Pursuant to Sections 7-1 of the Residential Mortgage License Act of 1987 (the "Act")[205 ILCS 635/7-1] and Section 1050.2170 of the rules promulgated thereunder (the "Rules") [38 Ill. Adm.
