CONSENT ORDER

The Department of Financial and Professional Regulation, Division of Banking, of the State of Illinois (“Department”) and James A. Scheffler (“Registrant”) hereby enter into this Consent Order (“Consent Order”) and stipulate and agree to the following:

STIPULATIONS AND ADMISSIONS

On November 18, 2009 the Department issued Order No. 2009-LO-75 (“Order”) citing Registrant for misrepresentation on his renewal application. Registrant filed a request for administrative hearing upon receipt of said disciplinary order. In lieu of proceeding to a formal hearing, the parties herein agree to resolve this matter pursuant to the terms of this Order.

TERMS AND CONDITIONS

WHEREFORE, the Department and Registrant agree as follows:

- I. Due to Registrant providing documentation in support of Registrant’s position that an inadvertent mistake was made by Registrant on his Renewal Application, the Department agrees to reduce his discipline.

- II. The Department reduces the fine in the Order to fifteen hundred dollars (\$1,500). The total fine in the amount of \$1,500 shall be due thirty (30) days after the effective date of this Order. The fine in the amount of \$1,500 shall be paid by means of a certified check or money order made payable to the:

- III. Registrant agrees to dismiss his petition for hearing and administrative review of Order and waives any right to re-file its petition, or file any petition or other appeal of said orders or of this Consent Order. Registrant acknowledges that he has had the opportunity to be represented by legal counsel in negotiating this Consent Order, and that he willingly enters into this Consent Order, and after full review, evaluation, and consideration and with full knowledge of his rights under the Act and Rules and Illinois Administrative Procedure Act.
- IV. The Department enters into the Consent Order for the purpose of imposing measures that are fair and equitable in the circumstances and that are consistent with the best interests of the people of the State of Illinois.

- V. The Consent Order shall be signed and dated by all the parties hereinafter and shall become effective on date the Department signs and dates the Consent Order.

The foregoing Consent Order is approved in full.
