## **CEASE AND DESIST ORDER WITH A FINE**

Pursuant to Sections 7-1 of the Residential Mortgage License Act of 1987 (the "Act")[205 ILCS 635/7-1] and Section 1050.2170 of the rules promulgated thereunder (the "Rules") [38 Ill. Adm. Code 1050.2170], a fine of \$5,000.00 is imposed against Derwin Moore (the "Respondent"), for holding himself out to the public as a natural person who, for compensation or in the expectation of compensation, either directly or indirectly makes, offers to make, solicits, places or negotiates a residential mortgage loan.

This fine will be imposed for conducting loan origination activities without being duly registered by the Illinois Department of Financial and Professional Regulation Division of Banking. A Department investigation of The Mortgage Professionals (MB 0005018) found that Respondent originated loans without being registered and said loans had discrepancies and resulted in a consumer complaint being filed with the Department.

IT IS THEREFORE ORDERED that Respondent immediately CEASE AND DESIST any and all loan origination activity, until such time as Respondent has complied with the provisions of the Act and the Rules and must pay within thirty (30) days the fine in the amount of \$950 by means of a certified check or money order made payable to the:
