Your participating in said mortgage fraud scheme which included false and dishonest representations and dealings was in violation of the Act and Rules and posed harm to lenders, the public, and others.

NOW IT IS HEREBY ORDERED that the Application for Loan Originator Registration of Mubeen Moinuddin is denied.
