# ORDER TO CEASE AND DESIST & ASSESSING FINE

The Illinois Department of Financial and Professional Regulation, Division of Banking ("Department") hereby issues to Stephanie Glasgow ("Glasgow") this ORDER TO CEASE AND DESIST & ASSESSING FINE ("Order"). This Order is authorized by and issued pursuant to the Article VII of the Residential Mortgage License Act of 1987 ("Act") [205 ILCS 635] and the rules promulgated thereunder ("Rules") [38 Ill. Adm. Code 1050.2170].

## **FINDINGS OF FACT**

The Department makes the following Findings of Fact:

- 1. That on February 3, 2007, the Department became aware of a complaint from the Real Estate section of the Division of Professional Regulation regarding unlicensed real estate brokering activities by Glasgow and Maurice Boston ("Boston"). Through this investigation it was found that Glasgow was also performing unlicensed loan originator activities;
- 2. That the complainants A.M. and S.J. ("Complainants"), owners of a real estate investment company, entered into several agreements with Boston. Boston referred Complainants to Glasgow who he introduced as a mortgage officer for Mortgage Company;
- 3. That Glasgow sent an email to Complainants which indicated that she was a "senior loan administrator";
- 4. That when Glasgow was interviewed by a real estate investigator she admitted that she stated on a mortgage disclosure form that she was a loan officer and that she also obtained financing for Complainants for two properties. That later the actual mortgage disclosure form was found and it was verified that Glasgow's name and signature were on the form; and
- 5. That it was further discovered that Glasgow never was a registered loan originator and that she never worked for Mortgage Company.

# **CONCLUSIONS OF LAW**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

Respondent's activities warrant a cease and desist with a fine pursuant to Article VII of the Act and Section 1050.2170 (c) of the Rules.

#### **ORDER**

#### NOW THEREFORE IT IS HEREBY ORDERED:

- 1. That Stephanie Glasgow shall cease and desist from all loan originating and solicitation activities;
- 2. That Stephanie Glasgow shall be and hereby is assessed a fine of \$2,500 for violating the Article VII of the Act and Rules section 1050.2170(a)(2);
- 3. The total fine in the amount of \$2,500 shall be due thirty (30) days after the effective date of this Order; and
- 4. The fine in the amount of \$2,500 shall be paid by means of a certified check or money order made payable to the:
