#### ORDER TO CEASE AND DESIST FROM UNLAWFUL RESIDENTIAL MORTGAGE ACTIVITIES AND ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking ("Department"), having conducted an investigation of CHRIS WILSON ("WILSON"), 728 E. Wilson, Lombard, Illinois 60148 in connection with his residential mortgage activities with PRESTIGE FINANCIAL CORPORATION, d/b/a InterTrustBanc Mortgage Company ("Licensee"), and found violations of the Residential Mortgage License Act of 1987 ("Act") hereby issues this ORDER TO CEASE AND DESIST FROM UNLAWFUL RESIDENTIAL MORTGAGE ACTIVITY AND ASSESSING FINE.

#### STATUTORY PROVISIONS

- 1. Section 1-4(jj) of the Act defines the "mortgage loan originator" as an individual who for compensation or gain or in the expectation of compensation or gain (i) takes a residential mortgage loan application, or (ii) offers or negotiates terms of a residential mortgage loan. Included in the definition are individuals who participate in residential mortgage loan modification activities.
- 2. Section 7-1A of the Act states, in part, it is unlawful for any individual to act or assume to act as a mortgage loan originator, as defined in subsection (jj) of Section 1-4 of the Act, without obtaining a license from the Department.
- 3. Section 7-11 of the Act authorizes the Secretary to issue a cease and desist order to compel the mortgage loan originator to comply with this Act or any other applicable law. A maximum fine is authorized of \$1,000 for each day for each violation of this Act or other applicable law or regulation that is committed, and may be double for repeat violations.
- 4. Section 7-13 of the Act provides a list of prohibited acts and practices for mortgage loan originators, including conducting any business covered by this Act without holding a valid license as required under this Act, MLOs are prohibited from violating any rules and regulations and engaging in conduct that constitutes dishonest dealings.

### FACTUAL FINDINGS

- 5. WILSON formerly held Loan Originator Registration No. 031.0002254 for the period of June 10, 2005 to April 25, 2011 when he was Refused to Renew.
- 6. On April 22, 2013, the Division of Banking received an anonymous complaint that Licensee was allowing unlicensed mortgage loan originators to originate loans.
- The Investigator investigated the complaint and confirmed with borrowers that WILSON originated 29 loans between August 30, 2011 through March 11, 2013 without a license for the following borrowers: N.A., E.C., D.C., D.C., W.D., R.D., J.D., H.E., R.L, L.L., J.M., A.M., L.M., C.N., T.P., J.R., J.R., R.R.(2 loans), B.S., C.S., A.S., D.S., M.S., T.S., J.V., R.V., E.W., and P.Y.

## LEGAL CONCLUSIONS

## BASED UPON THE ABOVE ALLEGATIONS, THE DEPARTMENT FINDS:

8. WILSON is in violation of Sections 7-13(6), (8) & (15) of the Act.

# NOW IT IS HEREBY ORDERED THAT:

- 1. CHRIS WILSON shall **CEASE AND DESIST** from engaging in mortgage loan originating activities in the State of Illinois pursuant to Section 7-11(c) of the Act.
- 2. CHRIS WILSON shall pay a **FINE** in the amount of \$57,000 (\$1,000 for the first loan and \$2,000 for each additional loan) as authorized under Section 7-11 of the Act. The fine is payable by certified check or money order within thirty (30) days of the effective date of this Order to the:
