#### ORDER SUSPENDING MORTGAGE LOAN ORIGINATOR LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking ("Department"), having been notified by the Illinois Department of Healthcare and Family Services ("HFS") of Mortgage Loan Originator E. Scott Ostrowski ("Ostrowski") delinquency in child support payments, and having documented violations of the Residential License Act of 1987 ("Act") [205 ILCS 635] and the rules promulgated under the Act ("Rules") [38 Ill. Adm. Code 1050], hereby issues this order for violations of the Act and Rules.

### STATUTORY PROVISIONS

- 1. Section 7-3(3) of the Act states that to be licensed the applicant has demonstrated financial responsibility, character, and general fitness so as to command the confidence of the community and to warrant a determination that the mortgage loan originator will operate honestly, fairly, and efficiently within the purposes of this Act. For purposes of this item (3) a person has shown that he or she is not financially responsible when he or she has shown a disregard for the management of his or her own financial condition. A determination that an individual has not shown financial responsibility may include, but is not limited to, consideration of (B) non payment of child support.
- 2. Section 7-11 of the Act states the Department may suspend a loan originator for violating the Act or any applicable law or regulation that is committed.

### FACTUAL FINDINGS

3. Ostrowski is an Illinois Mortgage Loan Originator holding License No. 031. 0001445 ("License").

Page -2- In the Matter of E. Scott Ostrowski

- 4. The Department received on May 13, 2015 a "Status of Child Support Payments" from HFS due to Ostrowski being over thirty days delinquent in making child support payments as ordered.
- 5. A Rule to Show Cause was sent to Ostrowski on May 14, 2015 giving him an opportunity to present proof he was no longer delinquent by May 28, 2015.
- 6. The Department did not receive the requested proof by May 28, 2015.

# LEGAL CONCLUSIONS

7. Ostrowski violated Section 7-3(3) of the Act.

# NOW IT IS HEREBY ORDERED THAT,

The Department **SUSPENDS** E. Scott Ostrowski's Mortgage Loan Originator License, MLO license No. 031.0001445, pursuant to 7-11 of the Act until notified by HFS of Ostrowski's compliance with his child support payments.

Absent a request for a hearing, this Order shall constitute a final administrative Order subject to the Administrative Review Law [735 ILCS 5/3-101 *et seq.*].
