

## CONTINUING EDUCATION (CE) FACT SHEET FOR 2020 REAL ESTATE BROKER RENEWAL

- The 2020 Broker Renewal deadline is September 30, 2020.
- Prior to renewing a license, the licensee shall be required to complete the required courses as described below.

### Summary of Continuing Education (CE) Requirements

#### If first issued a Broker License prior to February 1, 2018:

- **12-hours of CE is required:**  
This must consist of a 4-hour Core course and 8 hours of elective courses, of which one hour may be the Sexual Harassment Prevention Training course.

**Note:** 6 hours of Core (which includes 3 hours of Core A and 3 hours of Core B) taken prior to 7/1/2019 shall meet the Core requirement for this renewal. If only a part of the 6-hour Core was completed prior to 7/1/2019 (e.g. Core A was completed, but not Core B), the new 4-hour Core course, effective July 11, 2019, **must** be completed. The completed Core A or Core B may be applied towards the elective requirement.

#### If first issued a Broker License between February 1, 2018 and August 8, 2019

- **30-hours of Post License Education is required.**

#### If first issued a Broker License between August 9, 2019 and November 1, 2019

- **45-Hours of Post License Education is required**

**Note:** The new Post License course will include the required 1-hour of Sexual Harassment Prevention Training

#### If first issued a Broker License on or after November 2, 2019

- **No Post License Education or CE is required for this renewal.**  
A license issued during this period will have an expiration date of 4/30/2022.

### Certification of Compliance with Continuing Education (CE) Requirements

- 1) Each renewal applicant must certify, on the renewal application, full compliance with the CE requirements.
- 2) Active attorneys admitted to practice law pursuant to Illinois Supreme Court rule are exempt from CE but must certify on the renewal application to full compliance with the CE requirements.
- 3) The Department may require additional evidence demonstrating compliance with the CE requirements. It is the responsibility of each renewal applicant to retain or otherwise produce evidence of such compliance upon request.
