IMPORTANT DRE ACT UPDATES FOR THE NEW YEAR



In 2023, Public Act 103-0236 was signed into law that made important changes to the professional acts of the Division of Real Estate. The following measures will become effective on January 1, 2024.

- **Military:** Members of the Armed Forces who may have missed a renewal deadline or whose license expired while on active duty can pick up their license again for minimal cost. The Department will waive the continuing education and fee requirements for a broker, leasing agent, managing broker, home inspector, community association manager, or auctioneer within two years upon their return from service.
- **Listing Agreements:** To limit potential predatory practices and protect consumers, the Real Estate License Act of 2000 now requires that brokerage agreements include the promise of future business and offer clients an annual right to terminate a multiyear listing agreement.
- **Property Liens:** To further protect homeowners, liens cannot be placed on real estate property for unpaid commissions in relation to broker activity. The licensee may be subject to discipline if found doing so.
- **Illinois Residents:** Reinforcing an already established practice, those who are new to our State, or residents who simply choose to not use their social security number for security reasons, may elect to use a taxpayer identification number instead when applying for a license.
- **License on Hold:** Home inspectors can now join some of the other real estate professions and choose to put their license into inactive status for up to two years if it makes sense for their practice. The license can become active again upon completion of missed continuing education and payment of renewal fee.
- **Protected Groups:** Several disciplinary sections in the acts are now updated to incorporate violations against protected classes that are expanded by the Illinois Human Rights Act. Recent protected groups include those with arrest records, immigrant status, or prohibition against discrimination based on source of income in a real estate transaction.

LICENSURE TESTING IMPROVEMENTS



In an ongoing effort to make improvements across all aspects of the licensure process, the Illinois Division of Real Estate has partnered with Exam Vendor PSI Services, LLC to make improvements for our licensees and those seeking a Real Estate license. Over the month of October, PSI implemented several changes aimed at improving the overall experience and quality of their Exam products.

First, after an almost year long process, PSI and a team of volunteer Real Estate Subject Matter Experts from around the United States (including two Illinois Board members) updated the bank of Real Estate National Exam questions. The “Job Analysis” project, scheduled every five or so years, is focused on ensuring the National Exam remains relevant and applicable to the Real Estate Industries across the county. The new updated questions were put into action beginning October 2, 2023. The Division is excited to see how these updated questions perform over the next several months.

Second, PSI has transitioned its call center operations back to their operations in the United States. That phone number is 855-340-3893.

Lastly, PSI has implemented a new tool for State Regulators (including the Illinois Division of Real Estate) to, report, communicate, and resolve candidate issues. This new system will help PSI track and build reports to identify the most common issues. The compilation of this information will aide PSI to install further improvements and better understand the concerns felt by exam candidates.

CLARIFICATION FOR AUCTIONEERS



Questions regarding internet auction listing services have arisen and the Division of Real Estate points to the meaning of the definition set forth in the [Auction License Act](#).

Internet auction service means a website on the Internet, or other interactive computer service, that is designed to allow or advertise as a means of allowing users to offer personal property or services for sale or lease to a prospective buyer or lessee through an online bid submission process using that website or interactive computer service and that does not examine, set the price, prepare the description of the personal property or service to be offered or in any way utilize the services of a natural person as auctioneer.

An internet auction listing service would look for direction regarding licensure pursuant to the provision of the Act that states as follows: “Nothing in this Act shall be construed to apply to a person providing an internet auction listing service.” Recall that in 2017, that latter provision was added to the Act following enactment of P.A. 100-534 in recognition of the growing popularity of online platforms. The primary difference between some platforms is apparently the live streaming feature, which appears to be more of a social marketplace. Sellers can make videos about their products that are included on the platforms, but it is doubtful that this makes the seller a “natural person” serving as an “auctioneer,” since the actual bidding process is integral to the platform itself.

REGULATORY UPDATES FOR COMMUNITY ASSOCIATION MANAGERS



The Community Association Manager Licensing and Disciplinary Act's Rules ([68 IAC 1445](#)) were recently overhauled on June 2, 2023 by the Division of Real Estate and include the following updates:

- All requirements for community association firms to be licensed in Illinois, including identification of a designated community association manager for each entity;
- Continuing education requirements of 12 credit hours for each renewal cycle beginning in 2025; and
- Fidelity insurance requirements.

In June, the Division of Real Estate began issuing Community Association Management Firm licenses (CAM Firm). Within the first 120 days of the implementation, the Division issued 124 CAM Firm licenses.

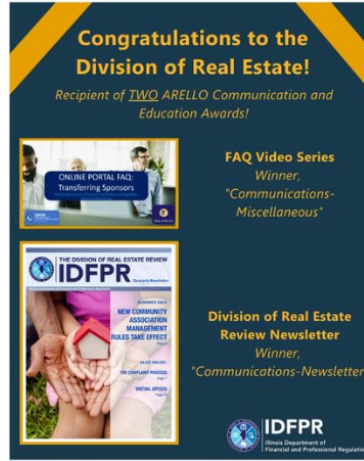
APPRAISAL COMPLIANCE REVIEW UPDATE



The Division of Real Estate prepared for its two-year compliance review from the Appraisal Subcommittee this fall. Multiple members of the staff worked to prepare for the first in-person visit since the COVID-19 pandemic swept the globe. These scheduled reviews help the Division maintain compliance with Federal Regulations. Members of the Federal Agency were at both the Springfield and the Chicago offices during their visit.

ACCOLADES & SPECIAL EVENTS

The Division of Real Estate was honored to win two Communication Awards from the Association of Real Estate License Law Officials (ARELLO) during the Association's Annual Conference. The Division took home the hardware for the [Division's Quarterly Newsletter](#) and the [Division's FAQ Video Library](#). Both the Newsletter and the FAQ Library have been well-received by licensees of industries regulated by Division.



Director Murphy and (then) Chief of Licensing Jeremy Reed attended the Annual "Calling Contest" at the 2023 Illinois State Fair. The event hosted by the Illinois State Auctioneers Association, included 15 licensed Auctioneers from around the state. The top prize went to Bill Burke who was named the 2023 Illinois State Auctioneer Champion. His win gave him and the first runner-up the honor to call the Sale of Champions hosted by Governor JB Pritzker.



Division of Real Estate Director Murphy and (then) Deputy Director Johnson represented Illinois at this year's Association of Appraiser Regulatory Officials' (AARO) Fall Conference in Salt Lake City, Utah. The Director and Deputy received important updates from our federal appraisal regulators and discussed various issues with other state regulators including appraisal bias and improving appraisal investigations.

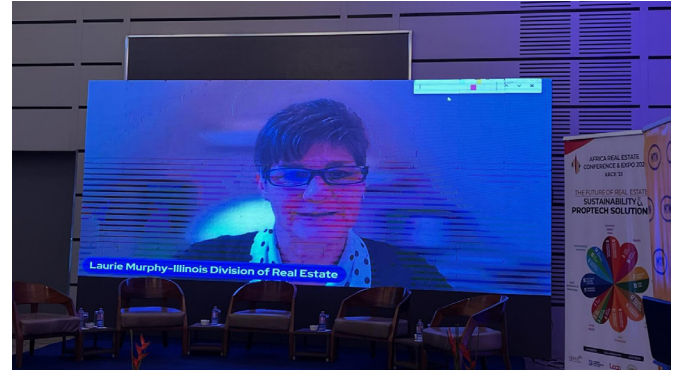

DRE NEW HIRES & PROMOTIONS

UNLICENSED

An LLC was ordered to cease and desist the unlicensed practice of real estate.

An individual was ordered to pay a \$1,000 civil penalty for engaging in licensed real estate activities while not licensed and not registered as an assumed business name.

Two individuals were ordered to pay a \$2,000 civil penalty jointly and severally and to cease and desist from engaging in real estate activities that required a license in Illinois.

One individual was ordered to cease and desist the unlicensed practice of community association management and pay a \$1,200 civil penalty for having engaged in the unlicensed practice of community association management.

A property management company and an individual were ordered to cease and desist the unlicensed practice of real estate and imposed a \$2,500 civil penalty jointly and severally for unlicensed practice in the leasing of 25 units.

APPRAISAL

Four certified residential real estate appraiser licenses suspended for failure to file and/or pay Illinois state income taxes.

Certified residential real estate appraiser license ordered to take 30 hours of education for submitting a misleading appraisal report.

Certified residential real estate appraiser license reprimanded, fined \$10,000, ordered to complete 15 hours of education, and shall not supervisor any real estate trainee appraisers due to certifying false statements on appraisal reports.

Certified residential real estate appraiser license reprimanded, fined \$7,500 and shall complete courses for aiding in unlicensed practice of appraisal, unprofessional conduct, engaging in gross negligence, developing and communicating appraisal reports that were misleading and inaccurate, and failed to provide a copy of the original appraisal report within 30 days of a written request.

COMMUNITY ASSOCIATION MANAGER

Community association manager license suspended for failure to file and/or pay Illinois state income taxes.

Community association manager license reprimanded and fined \$2,000 for having received a discipline from another agency on his Insurance Producer license, which involves the collection of insurance policy premiums for condominium associations that were in excess of the annual premiums and for failing to report the discipline to the Department.

Community association manager license fined \$1,000 for failing to account for or remit all property belonging to an association, including association money and documents, after his termination.

Community association manager license revoked for a minimum period of 5 years and fined \$5,000 for making unauthorized purchases using credit cards belonging to a client association and receiving check reimbursements from the client association by falsely representing that the association had approved the reimbursements.

HOME INSPECTOR

Three home inspector licenses suspended for failing to file and/or pay Illinois state income taxes.

Home inspector license fined \$500 for failing to provide information in response to a written request by a Department Investigator within 30 days.

REAL ESTATE

Eighty-eight real estate broker licenses suspended for failure to file and/or pay Illinois state income taxes.

Nine real estate managing broker licenses suspended for failure to file and/or pay Illinois state income taxes.

Three real estate residential leasing agent licenses suspended for failure to file and/or pay Illinois state income taxes.

Real estate residential leasing agent license suspended for violating the terms of an Order.

Real estate managing broker license fined \$2,000 and ordered to complete education for failure to give the Buyers the contract accepted and signed by both of the Sellers and for failure to produce documents to the Department upon request.

Real estate broker license suspended for being more than 30 days delinquent in the payment of child support.

Three real estate managing broker licenses suspended for a minimum period of 1 year and fined \$1,000 for failing to cooperate in a Broker Verification Report and providing information to the Department upon request.

Real estate broker license fined \$3,000 for engaging in licensed real estate activities prior to obtaining a license.

Real estate broker license granted on probation due to a prior felony conviction and prior license disciplines.

Real estate broker license fined \$1,000 and attend classes for engaging in advertising that was misleading, inaccurate, or contrary to the Real Estate License Act of 2000.

Real estate broker license revoked for failing to report, within 30 days, the entry of an administrative sanction that has an essential element of dishonesty or fraud or involves larceny, embezzlement, or obtaining money, property, or credit by false pretenses.

Real estate broker license fined \$500 for engaging in licensed real estate practice without a license.

Real estate managing broker license fined \$2,000 and ordered to complete education for operating under an assumed business name without registering that name with the Department, for failing to have an employment agreement with a sponsored licensee, for failing to keep documents relating to a transaction; for failing to provide documents to the Department upon request; and for failing to supervise a sponsored licensee.

Real estate broker license reprimanded and required to complete a class for unprofessional conduct during an interaction with a client.
