January 2026 Enforcement Actions

DIVISION OF PROFESSIONAL REGULATION

BARBER, COSMETOLOGY, ESTHETICS, HAIR BRAIDER & NAIL TECHNOLOGY

Marty Davis, Decatur, 006066222 - barber license is indefinitely suspended for being more than 30 days delinquent in the payment of child support.

Veejay Moore, Edwardsville, 006066280 - barber license is suspended for being more than 30 days delinquent in the payment of child support.

Clarence Brown, Chicago, 038010595 - chiropractic physician license indefinitely suspended due to Respondent's conviction of nine counts of Healthcare Fraud in the US District Court, Northern District of Illinois in November 2025.

Manjeet Chawla, Chicago, 036057504 - physician and surgeon license reprimanded and fined \$2,500 due to mismanagement of methotrexate administered to a patient and failure to communicate with another patient regarding the results of a biopsy.

Avi Factor, Cedarhurst, NY, 036170677 - physician and surgeon license indefinitely suspended for a minimum of one year due to Respondent's Medicare enrollment provider status being revoked in California in February 2024 and in New York in March 2024 due to affiliation that poses an undue risk.

Michael Fleck, Oak Park, 038012385 - chiropractic physician license has been placed in refuse to renew status due to billing for services and ordering tests without a license.

Abby Fredrickson, Shiloh, 036165488 - physician and surgeon license revoked after being suspended by the State of Colorado in August 2025 due to Respondent being criminally charged in the State of Minnesota with multiple counts of the felony offense Aiding an Offender - 2nd Degree Murder Intentional and Aiding an Offender - Accomplice After the Fact in May 2025.

Andrew Gomes, Sugar Land, TX, 036122584 - physician and surgeon license has been placed in refuse to renew status due to violations of the Controlled Substance Act and adverse actions taken by the State of Texas in December 2024, the US District Court, Western District of Texas in July 2025, and HHS in July 2025.

John Greager, Hinsdale, 036052071 - physician and surgeon license granted in part with conditions, including continued suspension of license until July 7, 2026, followed by indefinite probation with practice monitor for a minimum of six years.

Anil Gupta, Columbia, 036086275 - physician and surgeon license suspended for 30 days, followed by indefinite probation with multiple conditions and practice restrictions for a minimum of two years and fined \$45,000 due to a September 2025 Memorandum of Agreement with

DEA St. Louis Division based on inappropriate prescribing of Schedule II and IV controlled substances and a September 2025 Settlement Agreement based on submitting false claims for payment to Medicare & Missouri Medicaid in 2019. Illinois controlled substance license restricted to Schedules III through III.

Gregory Hall, Houston, TX, 036151186 - physician and surgeon license reprimanded due to misdiagnosis of a Lisfranc fracture, based on sister-state discipline by the States of Wisconsin and Maryland.

Jonathan Hemmert, Houston, TX, 036146556 - physician and surgeon license indefinitely suspended for a minimum of one year due to the State of Washington placing restrictions and terms on Respondent's medical license in July 2024 for failing to properly supervise staff at three medical clinics and using a product not yet approved as a medical device by the USDA.

Mohamed Jabri, Oak Brook, 036079512 - physician and surgeon license is reprimanded, must complete 10 CME's and be fined \$3,000 due to failure to perform a red reflex test and to refer the patient to a pediatric ophthalmologist.

Pramila Kasturi, McKinney, TX, 036105457 - physician and surgeon license restored from suspension to indefinite probation for a minimum of 15 months with multiple conditions.

Richard Kiang, Willowbrook, 036076533 - physician and surgeon license is suspended for being more than 30 days delinquent in the payment of child support.

Richard Kiang, Willowbrook, 336039748 - physician and surgeon-controlled substance license is suspended for being more than 30 days delinquent in the payment of child support.

Earl Maes, Springfield, MO, 036136384 - physician and surgeon license placed on indefinite surrender status due to May 2025 conviction of Theft from a Healthcare Benefit Program in Missouri.

Azfar Malik, St. Louis, MO, 036067092 - physician and surgeon license indefinitely suspended due to Respondent's conviction of two counts of False Statements Related to Healthcare Matters in the US District Court, Eastern District of Missouri in August 2025.

Sheela Manaparambil, Frankfort, 036084329 - physician and surgeon license indefinitely suspended for a minimum of 12 months due to failure to diagnose congestive heart failure in a patient.

Michael McKee, Las Vegas, NV, 036172434 - physician and surgeon license has been placed under a Chaperone Order as a result of being charged with two counts of Aggravated Murder.

Michael McKee, Las Vegas, NV, 036172434 - physician and surgeon license is temporarily suspended for failing to comply with a Chaperone Order put in place as a result of Respondent being charged with two counts of Aggravated Murder.

Kelsey Murray, Peoria, 036153006 - physician and surgeon license placed on permanent inactive status after Respondent's medical license was indefinitely suspended by the State of Ohio in October 2025 for being unable to practice medicine safely due to health.

Izuchukwu Okpara, Newhall, CA, 036178631 - physician and surgeon license issued and placed on indefinite probation for a minimum of two years with multiple conditions and practice restrictions due to Nevada State Board of Medical Examiners declining to grant licensure by endorsement in September 2020.

Ignacio Omengan, Rockford, 036101370 - physician and surgeon license reprimanded due to failure to diagnose a viral infection in an infant patient.

April Parker, Smithton, 036133079 - physician and surgeon license reprimanded due to failure to monitor fetal distress and timely procure a C-section for a patient, resulting in neurological injury to the infant.

Shehzad Qayum, Chesterfield, MO, 036147605 - physician and surgeon license restored from indefinite suspension and placed on inactive status.

Daniel Rivera, San Antonio, TX, 036141803 - physician and surgeon license reprimanded due to his Oklahoma medical license being indefinitely suspended and then restored to a five-year indefinite probation in January 2025 after diversion of controlled substances at work.

Serafino Sauro, Athens, 036159409 - physician and surgeon license is suspended for 30 days effective February 6, 2026, and thereafter placed on indefinite probation for a minimum of three years with multiple conditions and practice restrictions and **336118374**, controlled substance license indefinitely suspended for a minimum of 12 months due to inappropriate Controlled Substance prescribing to patients of his practice.

Robert Stears, Billings, MT, 036122268 - physician and surgeon license reprimanded due to failing to interpret and communicate the results of an xray, namely the arterial placement of right neck central line, based on sister-state discipline by the State of Wisconsin.

Stacy Syrcle, Milwaukee, WI, 036135033 - physician and surgeon license reprimanded due to failure to identify fetal distress.

Elton Tinsley, Orland Park, 036079325 - physician and surgeon license indefinitely suspended for a minimum of 12 months due to being indicated by the Illinois Department of Family and Children Services August 2023 as well as substandard surgical performance in three separate cases.

Diana Tracy, Carbondale, 036113471 - physician and surgeon license and **336074184**, controlled substance license are both indefinitely suspended for a minimum of four years effective retroactive to January 12, 2024, after she plead guilty to Conspiracy to Distribute Controlled Substances to her patient.

Ranjit Wahi, Burr Ridge, 036076159 - physician and surgeon license and controlled substance licenses **336039449/336-64407**, are all indefinitely suspended for a minimum of two years after Respondent plead guilty to conspiracy to dispense Schedule II controlled substances outside the scope of professional practice in October 2025.

Nathan Walker, Champaign, 036114466 - physician and surgeon license has been placed on indefinite probation for a minimum of two years with multiple conditions, must complete 50 Category I CMEs, and pay \$7,500 fine due to prescribing controlled substances to several patients of his practice without utilizing appropriate assessment tools.

Blaise Wolfrum, Schaumburg, 036079918 - physician and surgeon license and **336042914**, controlled substance license are to remain suspended pending demonstration of passage of the SPEX exam, upon which acceptance, the licenses shall be placed into probationary status for a minimum of three years.

NURSING

Brittany Anderson, Davenport, IA, 041436992 - registered professional nurse license has been placed on indefinite probation in Illinois due to a sister-state violation pending restoration from probation in Iowa.

Theresa Boayitey, Romeoville, 041525858 - registered professional nurse license has been temporarily suspended due to a finding that Respondent's continued practice constitutes an imminent danger to the public due to Respondent possessing unsatisfactory education requirements related to the federal criminal case Operation Nightingale.

Simech Bun, Bolingbrook, 041396772 - registered professional nurse license reprimanded and must complete 12 hours of continuing education courses on the topics of ethics, professionalism, and patient boundaries after Respondent exchanged contact information with a patient and thereafter began communicating with the patient between shifts.

Timothy Clark, Scranton, PA, 041575796 - registered professional nurse license has been voluntarily and permanently surrendered after Respondent plead guilty to and was convicted of one count of Harassment in Monroe County, and was resultingly disciplined by the Pennsylvania Board of Nursing; Respondent's conduct giving rise to the Harassment conviction occurred in Respondent's capacity as a certified registered nurse practitioner in Pennsylvania.

Sheena Cunconan, Pomeroy, IA, 041601230 - registered professional nurse license issued with reprimand based on a one-year probation imposed on her Iowa registered nurse license in 2019 for using a gift card belonging to a resident at a long-term care facility where she was employed.

Sheryl Deck, Chicago, 041210963 - registered professional nurse license is indefinitely suspended for a minimum of one year for termination from employment by Maxim Health Services in Lombard, Illinois for intoxication when arrived at patient's home and testing positive for alcohol level of 0.179 in July 2023.

John Doyle, New Lenox, 041445129 - registered professional nurse license is indefinitely suspended due to his license to practice as a nurse in California having been revoked due to unprofessional conduct. Respondent cannot file a petition to restore his Illinois license until his license is restored in California.

Kaylee Freeman, Springfield, 041394329 - registered professional nurse license is indefinitely suspended until Respondent complies with Respondent's December 16, 2025, Chaperone Order by providing an updated Written Plan of Compliance or until the disposition of Pike County.

Jesenia Gomez, Chicago, 043129717 - licensed practical nurse license is suspended for failure to file and/or pay Illinois state income taxes.

Moturayo Goodlow, Streamwood, 041530439 - registered professional nurse license is voluntarily surrendered as a result of having an unsatisfactory nursing education program related to the federal criminal case Operation Nightingale.

Terriest Haire, Chattanooga, TN, 041599408 - registered professional nurse license is issued with reprimand based on a 2023 probation imposed by the Tennessee Board of Nursing for accessing the medical records of a patient she was not caring for in 2021.

Ricky Higgins, Peoria, 041398251 - registered professional nurse license is restored from suspension to indefinite probation for a minimum of three years due to diversion and a misdemeanor theft conviction in 2022.

Alma Hukill, Murdock, 041284037 - registered professional nurse license and **043073422**, licensed practical nurse license are both placed in refuse to renew status due to entering a plea of guilty to a Class 3 felony possession of methamphetamine, and that Respondent was found guilty and was sentenced to a 24-month probation, alcohol treatment, and a \$3,665 fine.

Chijioke Jimonu, Country Club Hills, 043107590 - licensed practice nurse license, **209013712**, advanced practice nurse license, and **309009992**, advanced practice-controlled substance nurse license are all indefinitely suspended for a minimum of two years and **041387003**, registered professional nurse license is placed on indefinite probation for a minimum of two years based on Petitioner's Indiana nursing licenses being summarily suspended due to substandard care and over prescribing. The Indiana controlled substance license was ultimately revoked and advanced practice and registered nursing licenses in Indiana have been placed on probation.

Annette Johnson, Wheatfield, IN, 041304767 - registered professional nurse license reprimanded for testing positive for alcohol while at work at OSF Healthcare in Peoria.

Daleena Johnson, St. Louis, MO, 041464611 - registered professional nurse license, **209024012**, advanced practice registered nurse license and **309019368**, advanced practice-controlled substance license are all indefinitely suspended for a minimum of two years for admitting illicit drug use to her employer.

Megan Knox, Bartonville, 041388332 - registered professional nurse license is indefinitely suspended for being more than 30 days delinquent in the payment of child support.

Cindy Lambert, Bushnell, 043115290 - licensed practical nurse license has been placed in refuse to renew status due to felony convictions for burglary and for possession of a controlled substance.

Sarah Loebach, Ottawa, 041418259 - registered professional nurse license has been restored from indefinite suspension to being placed on indefinite probation for a minimum of three years.

Laura Miano, Hazelwood, MO, 041493159 - registered professional nurse license is indefinitely suspended for a minimum of one year after Respondent admitted to using methamphetamine.

Nancy Mobley, Godfrey, 043119625 - licensed practical nurse license is suspended for failure to file and/or pay Illinois state income taxes.

Heaven Primm, Chicago Heights, 043135508 - licensed practical nurse license is suspended for failure to file and/or pay Illinois state income taxes.

Jamila Sahabi, Calumet City, 04139438 - registered professional nurse license has been placed in refuse to renew status based on suspension of their registered nurse license in New York for failing to maintain or provide adequate medical records, financial records or other required information and made errors in prescribing, dispensing or administering medication or sedation.

Daniel Schmidt, Joliet, 041427699 - registered professional nurse license is automatically and indefinitely suspended for a minimum of 12 months due to violating the terms of a Consent Order with the Department by testing positive for alcohol.

Lusine Shirinyan, Stevenson Ranch, CA, 041440125 - registered professional nurse license has been placed on indefinite probation due to sister-state probation discipline in California for termination of employment from Kaiser Permanente in January 2022 due to self-administration of intravenous fluids (IV) from the supply room without proper authorization.

Michelle Tatum, St. Louis, MO, 041534531 - registered professional nurse license has been placed in refuse to renew status due to sister-state discipline in Missouri and felony conviction for making false statements to federal agents.

Jessica Teriet, Mount Vernon, 041392051 - registered professional nurse license restored from suspension and placed on indefinite probation with multiple conditions for a minimum of one year.

Marlyn Vallalobos, Chicago Ridge, 041288969 - registered professional nurse license indefinitely suspended for a minimum of one year due to diversion, impairment at work and unprofessional conduct when, upon being asked to leave her employment, she stole from a patient.

Ocean Whyte, Hoffman Estates, 041516976 - registered professional nurse license is suspended for failure to file and/or pay Illinois state income taxes.

Shaawn Wilson, Chicago, 043103609 - licensed practical nurse license is suspended for being more than 30 days delinquent in the payment of child support.

Crystal Yarnall, Klamath Falls, OR, 041432057 - registered professional nurse license reprimanded based on a reprimand from the Oregon Board of Nursing for practicing beyond her scope of practice, and substandard care or inadequate skill level.

Respondent must show ability to practice with reasonable judgment, skill, and safety and warrants public trust.
