March 2026 Enforcement Actions

SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced that Acting Director of Banking, Susana Soriano, Director of Financial Institutions, Francisco Menchaca, Director of Professional Regulation, Camile Lindsay, and Director of Real Estate, Laurie Murphy signed the following enforcement actions.

DIVISION OF PROFESSIONAL REGULATION

UNLICENSED

Laura Duffer, Lincoln, unlicensed - Ordered to cease and desist unlicensed practice of offering massage therapy services and assessed a \$1,000 civil penalty without being licensed as a massage therapist in Illinois.
