July 2026 Enforcement Actions

SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced that the Director of Professional Regulation, Camile Lindsay, Director of Banking, Susana Soriano, Director of Financial Institutions, Francisco Menchaca, and Director of Real Estate, Laurie Murphy signed the following enforcement actions.

DIVISION OF PROFESSIONAL REGULATION

UNLICENSED

JMC Security LLC, River Grove, unlicensed - ordered to cease and desist any unlicensed security practice and assessed a \$30,000 civil penalty against JMC Security, LLC and Jose Mendez, Elgin as Respondents operating a Private Security Contractor Agency and operating as Private Security Contractor without holding the appropriate licenses in Illinois, and for aiding and abetting unlicensed security practice.

Rosario Ramirez, Chicago, unlicensed - ordered to cease and desist the unlicensed practice of medicine, including but not limited to performing Botox injections, chemical peels, microdermabrasion, dermaplaning, microblading, micro needling and cool sculpting services on individuals in the State of Illinois.

Roxana Varas, Skokie, unlicensed - ordered to cease and desist the unlicensed practice of medicine in the state of Illinois.
