As of April 5th, all four of the application forms and instructions have been thoroughly reviewed and updated to provide a more minimalistic approach to providing information with what we hope will alleviate issues routinely received. The updated instructions will be "rolling out" over the next few weeks. In addition, we are working on several other forms that will be updated shortly and implemented over the next several weeks.

## **NEW ACTING SECRETARY NAMED FOR IDFPR**

## PROFESSIONAL DESIGN FIRM - RENEWAL REMINDER

The Professional Design Firm registration is set to expire on **April 30, 2019**. Renewal notices were sent February 6, 2019 via **EMAIL** to the Design Firm email address on file with the Division to all Design Firms that were in **ACTIVE** status.

- If you have not renewed your Design Firm yet or did not receive the renewal notice email, please contact the Department's technical assistance line at 800.560.6420.
- The firm registration cannot be renewed/reinstated unless a new managing agent is appointed OR
  the current managing agent reinstates his/her license prior to submitting the firm registration renewal/reinstatement.
- If the managing agent for the Firm did not renew his/her individual license, the Design Firm registration is automatically placed into **INOPERATIVE** status.
- If your firm offers multiple professional services and one of the managing agents for a profession is not **ACTIVE**, the Design Firm registration is automatically placed into **INOPERATIVE** status.
- No professional services can be performed in Illinois without an ACTIVE Design Firm registration.

## **ARCHITECTURE BOARD**

## NCARB ILLINOIS DIRECT REGISTRATION PROGRAM CHANGE

Prior to the Statutory change to the education requirement for initial licensure that took effect January 1, 2016, Illinois accepted a Pre-Professional degree for initial licensure. This required that applicants be "re-authorized" by the Department/NCARB to continue ARE testing through this program as an application is only active for three years in Illinois and then it expires.

We are now well past the three year mark for when this Illinois Statutory change became law. So, as of January 1, 2019, any applicant who was testing under the previous educational criteria has transferred to another jurisdiction to complete the testing, returned to school to obtain a NAAB degree or completed the NCARB-EESA process to meet Illinois requirements.

The result of this change is that we are working with NCARB to update the listed requirements on their website and remove the additional "step" for each actively testing ARE candidate to be "re-authorized" to test again. This is another way that the Department is ensuring that extraneous "hurdles" are removed to allow for an easier licensure process.

## NCARB HISTORY HAS DIRECT TIE TO ILLINOIS

(Borrowed from NCARB.org)

On June 3, 1897, Illinois enacted the first architectural licensing law in the United States. Two decades later, Illinois Architect Emery Stanford Hall organized a meeting with 14 other architects to discuss forming what would eventually become NCARB. He raised funds to get the organization off the ground—receiving a loan from the Illinois Society of Architects and providing money out his own pocket. Hall also set up the organization's first headquarters in his Chicago firm, where NCARB remained until his death in 1939. Illinois also was one of the first boards to join NCARB, along with Colorado and Wisconsin.

## MICHAEL FILIPSKI RE-ELECTED BOARD CHAIR



As required by law, the Board must elect a new chair each year. The LS Board voted at the January 22, 2019 meeting to elect Michael Filipski for a second term as Board Chair.

His specialized area of practice includes Boundary and ALTA surveys, land boundary issues and disputes, topographic mapping and construction surveying.

Mike is past president of the Northeast Chapter of the Illinois Professional Land Surveyors Association (IPLSA) and past Illinois Governor to NSPS. He was the executive editor of "Illinois Laws Relating to Survey, Title, and Real Property" and "Illinois boundary Law" (Lucas).

Section 1380.300 Standards of Professional Conduct

In order to safeguard life, health and property, to promote the public welfare, and to establish and maintain a high standard of integrity in the practice of professional engineering, the following Standards of Professional Conduct shall be binding on every person holding a license as a professional engineer and on all corporations authorized to practice professional engineering in this State.

#### The Standards of Professional Conduct specify items such as:

Professional Responsibility
Competence
Professional Integrity
Conflict of Interest
Employment Solicitation

## **EXAMINATIONS**

## NCEES EXAMINATIONS



NCEES develops and scores the Fundamentals of Engineering (FE), Principles & Practice of Engineering (PE), and 16 hour Structural Engineering (SE) exams for engineering licensure and the Fundamentals of Surveying (FS) and Principles & Practice of Surveying (PS) exams for land surveying.

**The FE exam** is your first step in the process to becoming a licensed professional engineer (P.E.) or structural engineer (S.E.). It is designed for recent graduates and students in their senior year of an undergraduate engineering degree from an EAC/ABET- accredited program.

**The PE exam** is designed to test for a minimum level of competency in a particular engineering discipline. It is designed for engineers who have gained a minimum of four years of work experience in their chosen engineering discipline.

The Structural Engineering (SE) exam tests for a minimum level of competency in structural engineering. It is designed for engineers who practice in jurisdictions that license structural engineers separately from other professional engineers. This 16-hour exam uses separate vertical and lateral components to test your ability to safely design buildings or bridges, especially in areas of high seismicity and high wind.

**The FS exam** is generally your first step in the process to becoming a professional licensed surveyor (P.S.). It is designed for recent graduates and students who are close to finishing an undergraduate surveying degree from an ABET accredited program. The FS exam is a computer-based exam administered year-round in testing windows at NCEES-approved Pearson VUE test centers.

**The PS exam** tests your ability to practice the surveying profession competently. It is designed for surveyors who have gained at least four years of professional experience.

## NCARB EXAMINATIONS

The Architect Registration Examination® (ARE®) is a multi-division exam used to assess your knowledge and skills regarding the practice of architecture. Developed by NCARB, the exam is accepted by all U.S. jurisdictions and is a key step on the path to earning a license.

The ARE is designed to assess aspects of architectural practice that affect the integrity, soundness, and health impact of a building. The exam also assesses an architect's responsibilities within firms, such as managing projects and coordinating the work of other professionals.

## **EXAMINATIONS**

## NCEES EXAM REGISTRATION IN ILLINOIS

BEFORE you register for NCEES exams under the Illinois jurisdiction, you must meet Illinois educational requirement. Regardless of the exam you are applying to sit for, the educational requirement is always based on the BS degree, not a post -graduate degree. Foreign educated applicants may have additional requirements to complete, refer to the current requirements stated on the application instructions.

#### Exams under the Professional Engineer Act: (FE and PE)

**ONLY** approved program applicants may <u>directly register</u> with NCEES and CTS —the test administrator. All non-approved applicants MUST apply to the Department for review of your education and approval to sit for any exam BEFORE you register with NCEES or CTS. We recommend that you review the Professional Engineering Practice Act and Administrative Rules here: <a href="https://www.idfpr.illinois.gov/profs/ProfEngineer.asp">https://www.idfpr.illinois.gov/profs/ProfEngineer.asp</a>

- To sit for the FE exam in Illinois, the approved education is a graduate of (or a senior in) a US EAC/ABET BS program, pursuant to Section 1380.210 of the Administrative Rules.
- To sit for the PE exam in Illinois, the approved education is a graduate of a US EAC/ABET BS program, pursuant to Section 1380.210 of the Administrative Rules.
- The PE Board will also accept non-approved engineering and Related Science degree's if they meet the requirements pursuant to Section 1380.220 of the Administrative Rules.

#### Exams under the Structural Engineer Act: (FE and 16-hour SE)

**ALL** applicants MUST apply to the Department for review of your education and approval to sit for any exam BEFORE you register with NCEES or CTS. We recommend that you review the Structural Engineering Practice Act and Administrative Rules here: <a href="https://www.idfpr.illinois.gov/profs/se.asp">www.idfpr.illinois.gov/profs/se.asp</a>

- The approved education is a BS degree in Engineering or Architecture with 18 semester hours of Structural Design/ Analysis coursework, pursuant to Section 1480.120 of the Administrative Rules.
- The SE Board will also accept certain ABET BS degree's and Related Science degree's, if they meet the requirements pursuant to Section 1480.120 of the Administrative Rules.

#### Exams under the Land Surveyor Act: (FS, PS and IL Jurisdictional)

**ALL** applicants MUST apply to the Department for review of your education and approval to sit for any exam BEFORE you register with NCEES or CTS. We recommend that you review the Professional Land Surveyor Practice Act and Administrative Rules here: https://www.idfpr.illinois.gov/profs/LandSurv.asp

- To sit for the FS exam in Illinois, the approved education is a BS degree in in Land Surveying from an accredited US University or an applicant in their senior year of said program (the degree must be conferred within 12 months of taking the FS exam).
- To sit for the PS and IL Jurisdictional exam in Illinois, the approved education is a BS degree in in Land Surveying from an accredited US University.
- The LS Board will also accept any BS degree that has 24 semester hours of Land Surveying coursework, if they meet the requirements pursuant to Section 1270.15 of the Administrative Rules.

## **APPLICATION INFORMATION**

## IMPORTANT TIPS WHEN APPLYING TO THE DEPARTMENT

- If you have questions regarding the application process, we recommend that you contact the Department yourself and not a friend, spouse, mother/father, etc. This will enable you to receive direct information from the Department.
- We recommend that you pay your application fee by personal or business check. That way you can
  track when the payment has been processed by the Department. Typically our unit will receive your
  application for initial review 2-4 business days after the payment has been processed by our accounting unit.
- If you are applying for your initial license with this Department and have submitted any supporting
  documents to Continental Testing Services (CTS) for exam registration— official transcripts for your
  BS degree (showing conferral date), name change documents, exam verifications, etc., the department should receive those documents from CTS for use with your license application. You do NOT
  need to submit additional copies of documents unless requested by the Department.
- Applicants applying for licensure for the Professional Engineer, Structural Engineer or Land Surveyor
  profession may submit an NCEES Record as supplemental documentation to the required license
  application. Illinois accepts the NCEES record for the education and examination scores. The experience aspect of the record is not accepted in Illinois as each profession requires the respective VE
  (verification of employment) form to be completed.
- Applicants applying for licensure as an Architect are required to read the Act and Rules and sign/ date a self-written affidavit attesting that he/she has read and understands the Illinois Architecture Practice Act and Administrative Rules. This requirement is the most overlooked item when initially sending an application to the Department.
- If you are applying for licensure by Endorsement of license from another U.S. jurisdiction, Illinois allows for self-verification of your experience on the respective VE form if you were operating under your own license.
- The most important tip is to read the application instructions for the license you are applying for. The instructions will give you precise information on how to properly complete the application and apply for your license.

## LICENSE INFORMATION

## NEWLY LICENSED BY ILLINOIS?

Ve recommend that you review the code enforcement manual to ensure that you and your Design Firm are in compliance with all applicable requirements as well as find an example to use when you purchase your Illinois seal.

linois does not supply a seal or approves any vendors. ′ou may purchase your seal at any vendor you choose. As long as it is a reproducible seal (non-embossed) it will be accepted.

### NEED AN EXAM/LICENSE CERTIFICATION?

The Department has implemented an Electronic Exam/License Certification process through the online portal system.

**Note:** You will receive a courtesy copy of your current license information typically within 30 minutes of processing, however the intended licensing jurisdiction, NCEES or NCARB will additionally receive an official license certification with scores for any exam passed in Illinois.


