OPENING STATEMENT

Dr. Reddy read the following opening statement: *This meeting is being conducted by audio or video conference without the physical presence of a quorum of the members because the Governor of the State of Illinois has issued a disaster declaration related to public health concerns and an in-person meeting is not practical or prudent because of the disaster described in that declaration. This meeting is further being conducted by audio or videoconference because the Secretary of the Illinois Department of Financial and Professional Regulation has determined pursuant to the provisions of Section 7 of the Open Meetings Act that an in-person meeting is not practical or prudent because of a disaster. All votes will be conducted by roll call, so each member's vote on each issue can be identified and recorded.*

OPEN MINUTES - Complaint Committee

A motion was made and seconded (Dr. Hofmann/Dr. Matzner) to approve the open session minutes for the Complaint Committee meeting on June 1, 2022. Roll call vote - Yes: Dr. Reddy, Dr. Laporta, Dr. Dray, Dr. Hofmann, Dr. Matzner, Ms. Moellering, Dr. O'Mara, Dr. Goyal, Mr. Marion, Mr. Thom; No: None. The motion passed.

CLOSED SESSION

A motion was made and seconded (Dr. Matzner/Ms. Moellering) to enter closed session pursuant to Section 2 (c)(15) of the Open Meetings Act. Roll call vote - Yes: Dr. Reddy, Dr. Laporta, Dr. Dray, Dr. Hofmann, Dr. Matzner, Ms. Moellering, Dr. O'Mara, Dr. Goyal, Mr. Marion, Mr. Thom; No: None. The motion passed and the session closed at 7:35 a.m.

The closed session meeting of the Complaint Committee included review and recommendations for closed session minutes, 21 complaints and 12 mandatory reports.

Close 19 complaints - 3 with letter of concern; Defer 1 complaint for additional information; Refer 1 complaint for prosecution; Close 7 mandatory reports - 1 with letter of concern; Refer 4 mandatory reports for prosecution; and Approve closed minutes from the June 1, 2022 Complaint Committee meeting.

There being no further business to be brought before the Complaint Committee, a motion was made and seconded (Dr. Laporta/Ms. Moellering) to adjourn the meeting. The motion passed by a voice vote and the meeting adjourned at 8:12 a.m.
