For example: Physicians who have privileges and are allowed to perform IV sedations are submitting cases showing only oral sedations are being presented during practice.</p>	<p>back-and-forth communication.</p> <p>David Avenetti and Brittaney Hill, UIC, Pediatric Dentistry, addressed this concern by indicating that there should be different levels of permitting to align with the different levels of sedation.</p>

Illinois Dental Hygienists Association	<p>Laura Boust, IDHA, is present to present to the board. Just attended the annual session which went well. IDHA just won a community grant from Delta Dental of Illinois that will expand public health dental hygienist certification programs.</p>	
Dental Assisting National Board	<p>Adam Block, DANB, is present to present to the board. DANB hosted the Dental Assistant stakeholder forum on the future workforce in Chicago in July 2022. They focused on forming a workforce coalition, improving workforce development plan, building partnerships to enhance diversity, focusing on outreach and recruitment models, and developing a uniform model for dental assistant training education and credentials. It was determined that dental assistants have left the profession due to insufficient pay, negative work culture, and feeling overworked, or dealing with job stress.</p>	<p>Solutions to prevent dental assistants leaving the profession in the future include increasing competitive benefits such as health insurance and paid leave, responsive compensation (wages should be accessed annually), and developing positive workplace culture.</p> <p>Illinois passed a bill at the beginning of the year (HB4645) that establishes a loan repayment and scholarship program</p>
