DIRECT SERVICE HOURS IN POST DOCTORATE SUPERVISED EXPERIENCE	The Board discussed whether or not the Rules should specify a minimum required number of hours or percentage of time spent in direct clinical service during one's post doctorate experience. So far the Board has suggested through the Fact Sheet for New Graduates in Psychology that this number is 50%. Question was raised as to whether post doctorate experience should be required at all. There was a report that many states do not require post doctorate experience at all.	Motion was made and seconded (Cushing/Dyson) to require a minimum of 50% hours of post doctorate experience be spent in direct clinical service. Discussion on whether or not to eliminate the post doctorate requirement all together was postponed. Counsel Craig will investigate the number of other states that do not require post doctorate hours.
