### **OPEN MINUTES**

A motion was made and seconded (Reddy/Moellering) to approve the open session minutes for the Medical Board meeting on June 21, 2023. The motion passed unanimously. Dr. Jameel abstained.

## **RECOMMENDATIONS** made by the Complaint Committee in closed session

Mr. Robertson reported that Complaint Committee made the following recommendations in closed session:

Approve closed minutes from the June 21, 2023 Complaint Committee meeting, Close 13 complaints - 5 with a letter of concern, Refer 9 complaints for prosecution, Close 13 mandatory reports - 4 with a letter of concern, and Refer 5 mandatory reports for prosecution.

A motion was made and seconded (Reddy/Matzner) to accept the recommendations made during the closed session meeting. The motion passed unanimously.

# **RECOMMENDATIONS** made by the Medical Board in closed session

Mr. Robertson reported that Medical Board made the following recommendations in closed session:

Approve closed minutes from the June 21, 2023 Medical Board meeting; Approve 3 subpoenas; Approve 7 consent orders; and Approve 1 variance from the USMLE 7-year requirement in 68 Ill. Adm. Code Section 1285.60 (a)(7).

A motion was made and seconded (Moellering/Matzner) to accept the recommendations made during the closed session meeting. The motion passed unanimously.

### **REPORTS**

Greg Marion, Chief of Medical Investigations reported that for the period of 6/1/23 to 6/30/23: 107 complaints were received, 25 cases were referred to prosecutions, and 117 cases were closed. Also, as there were 457 open investigations with an average caseload of 57 cases per investigator.

Shami Goyal, M.D., Chief Medical Coordinator reported there are 239 cases assigned to the medical coordinators of which 39 are agreements of care, counseling, or treatment (CCT) and that there are 251 cases being monitored by the probation unit.

Brandon Thom, J.D., Chief of General Prosecutions reported that as of 7/3/23, there were 793 cases open with the medical prosecutions unit of which 25 cases are related to tax liability.

#### ADJOURNMENT

There being no further business to be brought before the Medical Board, a motion was made and seconded (Reddy/Matzner) to adjourn the meeting. The motion passed and the meeting adjourned at 9:07 a.m.
