Call to Order	Marla Jackson, Chairperson of the Community Association Manager Licensing and Disciplinary Board, noted for the record that a quorum of board members in attendance was established at 11:06 am.	
Approval of Open Minutes	The Board reviewed the Open Minutes from the September 17, 2024 Community Association Manager Licensing and Disciplinary Board meeting. Licensing Report	The 2024 Licensing Report as of October 2024 was presented and distributed. A copy of the report is attached to and made a part of these minutes. Nathaniel Chandler noted that individuals or entities wanting to offer pre-license and/or continuing education courses must register as education sponsors and also apply to have their pre-license and/or contining education couses approved by the Department. Mr. Chandler emphasized that even if providers are referenced in the Rules they must become education sponsors and their courses must be approved. The forms that must be completed by CAM education sponsors, pre-license and continuing education courses are posted on the Department's website at idfpr.illinois.gov/dre, and accessible by clicking on the community association manager link. The Department website also includes a 2025 continuing education fact sheet, and a list of approved CAM education sponsors and courses. Mr. Chandler mentioned that if anyone has questions or needs assistance in submitting their application(s) they may contact him. Ms. Levatino emphasized that if a licensee takes a continuing education course from a provider not sponsored with the Department, that licensee will not receive continuing education credit.

	Ms. Skelley asked whether Phoebe Neseth could assist in informing the Illinois CAM industry that Illinois providers need to register their school and courses with IDFPR for licensees to receive continuing education credit. Board members may also provide licensees with this information.
