Licensing and Education Report	The 2024 Licensing Report for activity conducted in November was presented and discussed. A copy of the report is attached to and made part of these minutes. Nathaniel Chandler updated the Board on the auction license renewal that is currently in progress. Nathaniel Chandler said the renewal deadline is December 31, 2024, and at this time 35% of individual auctioneers have renewed and 44% of auction firms have renewed. The licensees have until December 31, 2024, to renew online. The online renewal will remain available for another month after the deadline; however, a late fee will be assessed. Once the online renewal closes, the	

	auctioneers may renew with a paper renewal application that is available on the IDFPR website. They may pay via ePay for the renewal and the late fee, and then email the completed renewal application to <u>FPR.realestate@illinois.gov</u> .
