Mr. Marion reported for the month of April 1-10 2025: 62 complaints were received; 16 complaints were referred to Medical Prosecutions for review; 73 complaints were closed; there were 548 open investigations; and the average caseload for an investigator was 91 cases.

Dr. Goyal reported that as of April 16, 2025, there were 137 cases assigned to the medical coordinators with 221 agreements of care, counseling, or treatment (CCT), and 334 cases monitored by the Probation unit.

Ms. Pipolo reported that as of April 16, there were 936 open cases assigned to the Medical Prosecutions unit including 5 tax liability cases.
