#### **Education Committee**

Motion made/seconded to approve a feasibility study in accordance with 68 IAC 1300.340 (a)(2) for a new Practical Nursing program that will be provided by Stellar Career College located at 205 W Randolph St, Ste 200; Chicago, 60606. Motion passed unanimously.

Motion made/seconded to approve a feasibility study in accordance with 68 IAC 1300.340 (a)(2) for relocation of an extension campus for an ADN ladder program with PN exit option provided by Spoon River College. The extension campus is relocating from 208 S. Johnson; Macomb, 61455 to 2500 E Jackson; Macomb, 61455. Motion passed unanimously.

Motion made/seconded to approve the continuous placement of student nurses from Marquette University College of Nursing in Milwaukee, WI for clinical placement within academic institutions and clinical facilities located in Illinois. Motion passed unanimously.

## Discussion - Remediation Strategies for IL Programs with less than 75% Pass Rates

A remediation plan requirement is found in 68 Illinois Administrative Code 1300.230 (b)(3) for nursing education programs whose graduates have an annual pass rate of less than 75% for their first time taking the National Council Licensing Examination (NCLEX). The Board approved a remediation plan in 2016 setting forth strategies for nursing programs to implement to increase their annual pass rate to 75% for graduates taking the NCLEX for the first time. The remediation plan was revised by the Board in 2021 and the plan was last reviewed by the Board in 2023. The Board discussed further revisions to the Administrative Support section of the remediation plan to

address organizational changes and efforts to promote program stability within the nursing program. A motion was made and seconded to implement changes to the remediation plan as discussed.

# **Discussion - Nurse Portfolio Credentialing Commission**

The Division received an inquiry from an Advanced Practice Registered Nurse (APRN) licensed in Illinois who received notification from the American Nurses Credentialing Center (ANCC) that ANCC transferred their <u>Advanced Genetics Nursing (AGN-BC)</u> and <u>Genetics Nursing (RN-BC)</u> certification programs to the <u>Nurse Portfolio Credentialing Commission</u> (NPCC) in February 2025. Accordingly, as of *March 14, 2025*, ANCC is no longer administering the Advanced Genetics Nursing or Genetics Nursing certification renewal applications and NPCC is responsible for all activities related to the renewal of these certifications.

The Illinois APRN asked the Division whether an NPCC certification in Advanced Genetics Nursing and Genetics Nursing would qualify for as an acceptable certification in accordance with 68 Illinois Administrative Code 1300.400 for the purpose of renewing an Illinois APRN license pursuant to 68 IAC 1300.40 (a).

This matter was set aside pending receipt of information showing that the certifying body meets the criteria outlined in 68 IAC 1300.40 (a)(3).
