REMINDER	Tomson reminded the Board that the 2 nd Tuesday of November is a state holiday (Veteran's Day) and therefore the November meeting will be held on November 4, 2025 rather than November 11, 2025.	
MINUTES ACCEPTANCE	Board members reviewed the minutes of open session from the July 8, 2025 meeting.	Motion was made and seconded to accept the minutes. Motion carried.
HR 0334 IL MPJE	Representatives from UIC Retzky College of Pharmacy, Roosevelt University College of Science Health & Pharmacy, and NABP presented to the Board concerns surrounding the IL MPJE. Glen Schumock and Melissa Hogan were representing not only their own colleges, but all the Illinois Schools of Pharmacy. Jasmina Bjegovic represented NABP and presented information in response to the Board's July questions. The Uniform MPJE is expected to be available in June 2026. Concern was raised about the Department's transition to require ITIN in lieu of SSN for international graduates, specifically in reference to interns. The process to obtain an ITIN involves confirmation of employment, however interns are not paid employees, so pharmacy schools must provide additional information to international students to help them obtain an ITIN.
