Ms. Akram apologized for any past confusion on the role of these Board positions.</p>
<p>Old Business Minutes Approval</p>	<p>The Board members reviewed the open minutes from the Board meeting held on July 15, 2016</p>	<p>Subsequent to review, a motion was made and seconded to approve the open minutes from the July 15, 2016 meeting. (Pliskin/Murray). Motion passed.</p>
<p>Rules Updates</p>	<p>Attorney Akram told the Board that approval from the Governor's office to file the Rules on First Notice has been received.</p>	<p>The Rules changes should be filed in the Illinois Register on First Notice on September 30.</p>
<p>The Psychology Interjurisdictional Compact (PSYPACT) – Lisa Grossman, PhD, JD</p>	<p>Dr. Grossman provided an overview of the PSYPACT Compact. The Compact presents a solution for interstate practice and protection of the public. She presented Guidelines for the Practice of Telepsychology and the Articles of the Compact. She explained that three states have bills pending for adoption of the Compact and additional states have expressed interest in this initiative.</p>	<p>It was noted that the Illinois Psychology Practice Act allows for up to 10 days of temporary practice for psychologists licensed in other states. The Board agreed that license portability is an important issue in health care today and telepractice is a part of this initiative. The Board thanked Dr. Grossman for her presentation.</p>
